Response to Questions #1

for

Faulkner-Wheeler Joint Ditch Project

Issued: August 27, 2020

Letting: September 8, 2020 at 10:00 A.M.

The following are responses to nine questions that our office has received via email with regards to the above mentioned project.

1. Can the work be performed in crops?

As stated in the Bid Package, the project's completion date is October 1, 2021. Construction start time will be discussed after the award of the contract. The property owners are aware that the winning contractor may request to perform the work in the summer of 2021 and the property owners have tentatively agreed for the work to be performed during crop season if necessary.

2. Is all the existing tile that needs to be hooked up in a lump under the item "SPEC 400 ft. Miscellaneous tile connections (including tees, couplers, etc)?"

Yes.

3. Do we have to hydroseed?

Yes.

4. How much of the ditch do we have to clean out?

Per Note 2 on Page 2 of the Plans: 125-feet of ditch will need to be cleaned out.

5. With the removal of the concrete headwall with this be enough Rip Rapp or will we have to haul in more?

Per Note 2 of the General Notes: "ITEM 601: [Bid] quantity may be reduced pending anticipated approval from the The Engineer to use material removed per ITEM 202 for rip-rap"

6. With the Hickenbottom do we have to use tees? Or can we use a breather?

ITEM 611, Hickenbottom, Closed 8" diameter x 40" tall, to include appropriately-sized tees.

7. What does the Embankment involve?

Per page 2 of the Plans, Embankment involves the filling and compaction of 75-feet of existing ditch that has an approximate area of 77.2 square-feet. This work is to be done in accordance with Item 203 in 2019 ODOT CMS Specifications.

8. Are there two owners to be listed on the bid bond ? If so, the names and addresses please.

Bid Bond is to be issued to the Logan County Commissioners.

9. What is the liquidated damages cost?

Per General Condition #22 in the Bid Package: "For each calendar day that any work shall remain uncompleted after the contract completion date, the liquidated damages, as described in 108 of the State of Ohio, Department of Highway's Materials and Specifications, dated January 1, 2019, may be imposed."
