Bidders must comply with the provisions of the Americans with Disabilities Act of 1990.

As specified in R.C. 153.54, a bidder must submit a bid guaranty in the form of either:

- (1) a bond for the full amount of the bid, or
- (2) a certified check, cashier's check, or letter of credit in the amount of 10% of the bid.

The Logan County Board of Commissioners reserves the right to reject any and all bids and to waive any defects in bids.

\*Reflective Sheeting Type G Materials must be approved by the Office of Traffic Engineering as meeting the requirements of ODOT Supplement 1049.

\*Only Rib back sign posts will be accepted. U-Back sign posts are unacceptable. One end must be tapered.

\*All signs and blanks which are 30"x 30" or larger are to be punched with three holes in lieu of two holes.

\*All critical warning signs are to be fluorescent yellow.

\*All pedestrian, school, and bicycle crossing series are to be fluorescent yellow green.

**OHIO REVISED CODE**

**SECTION 3517.13**

Ohio Revised Code Section 3517.13 I(3) and J(3) requires that no agency or department of this state or any political subdivision shall enter into any contract for the purchase of goods costing more than ten thousand dollars with a corporation, individual, partnership or other unincorporated business, association, including, without limitation, a professional association organized under Chapter 1785 of the Revised Code, estate, or trust unless the contract includes a certification that the individuals named in Revised Code, estate, or trust unless the contract includes a certification that the individuals named in Revised Code Sections 3517.13 (I)(1) and (J)(1) are in compliance with the aforementioned provisions. The bidder is required to complete the affidavit provided. Failure to submit the required form with the proposal/bid package could deem the bidder's response to be non-responsive and disqualified from receiving further consideration.



Corporation/Business Trust has made, within the two previous calendar years, one or more contributions totaling in excess of two thousand dollars to the holder of the public office having ultimate responsibility for the award of the contract or to the public officer's campaign committee, and I understand that the holder of the public office having ultimate responsibility for the award of the contract includes any member of the Board of County Commissioners of Logan County, Ohio.
