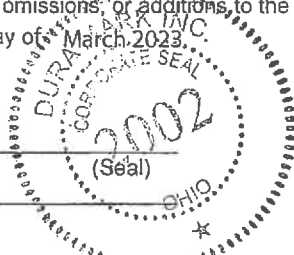

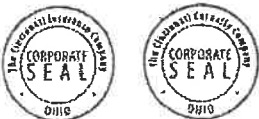

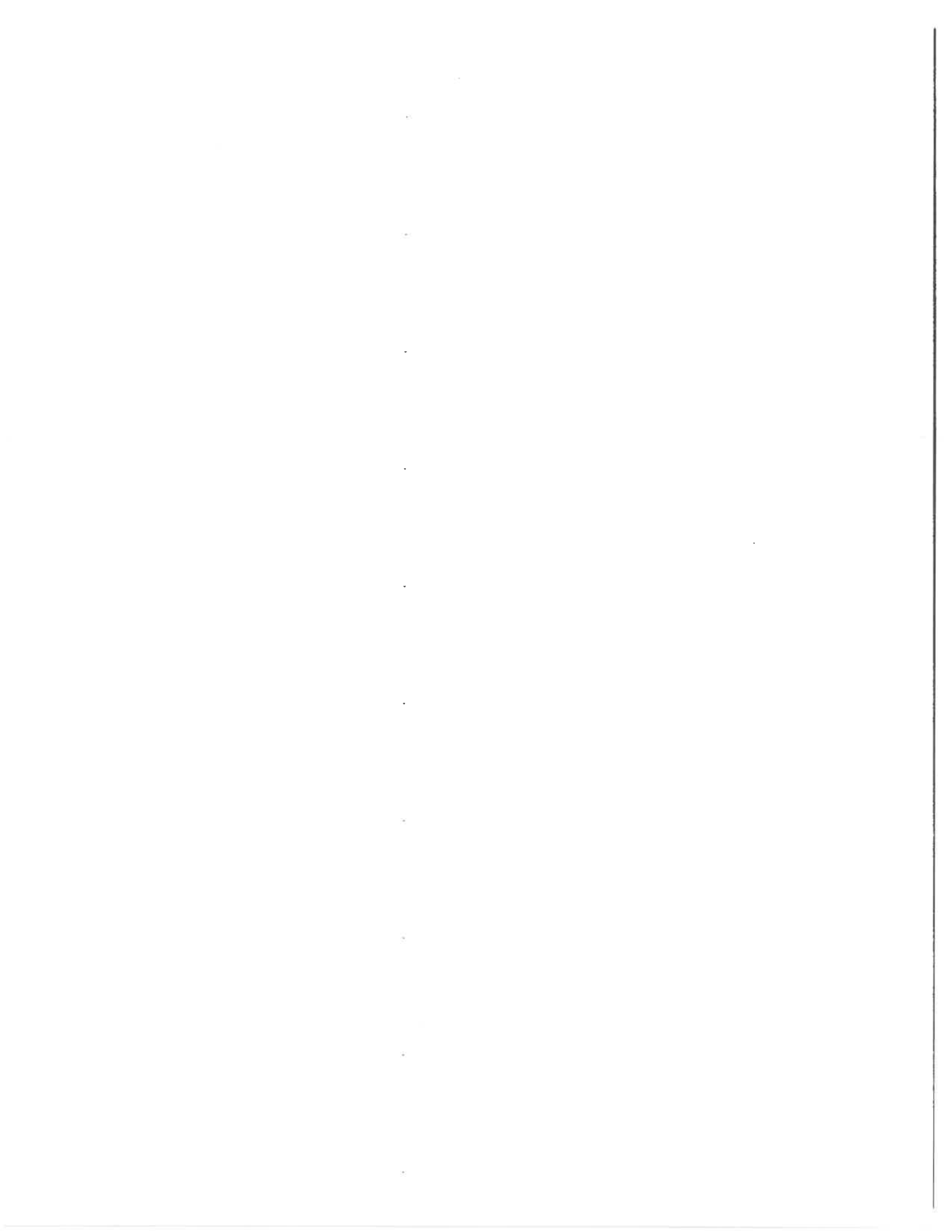
Section 4123.54 of the Ohio Revised Code requires notice of rebuttable presumption.
