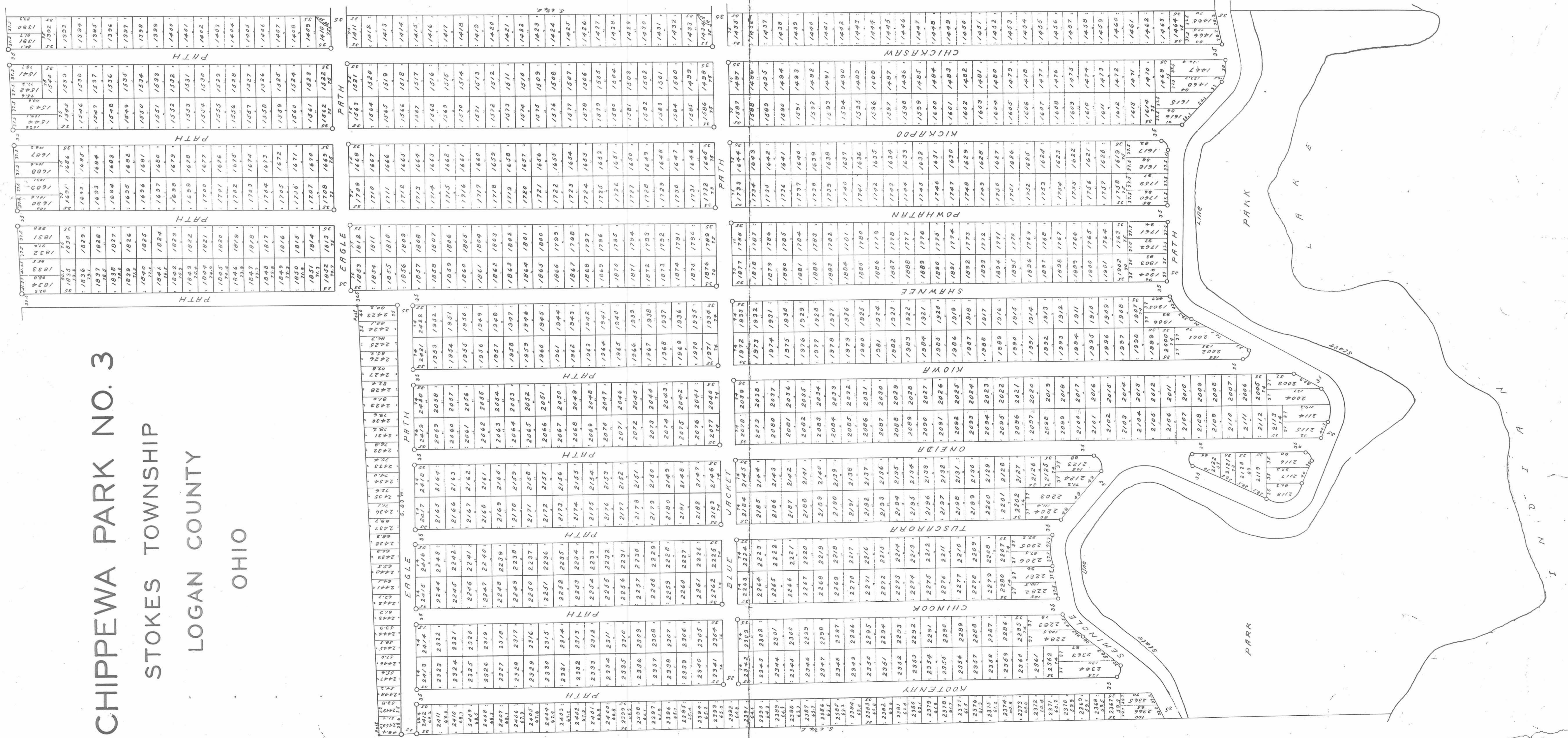


# CHIPPEWA PARK NO. 3
