The annexed Plat marked Plat of M<sup>rs</sup> Beth's addition to the Town of Bellefontaine as surveyed by H. C. Moore August 8 & 9<sup>th</sup> A. D. 1872, is a representation of one hundred and eighty one lots, together with the Streets and Alleys therein represented, as surveyed and laid off by said H. C. Moore on the said 8 & 9 days of August A. D. 1872 for and under the direction of J. N. McBeth of Bellefontaine Ohio; The land occupied by said Lots, Streets & Alleys being the N. W. west corner of the N. W. quarter of Section No. thirty four, (34) Town No. four (4) and Range No. fourteen (14) and the N. E. corner of the N. E. quarter of Section No. four (4) Town No. three (3) and Range No. fourteen (14) E. T. No. R. The entire plat contains Sixty Eight & <sup>36</sup>/<sub>100</sub> acres, of which 39<sup>32</sup>/<sub>100</sub> acres are in said Section No. 34, Situate in Lake Township, and 28<sup>97</sup>/<sub>100</sub> acres are in said Section No. 4 Situated in Garrison Township, all of which is located in the County of Logan, and State of Ohio. All the Streets are 60 feet wide, except Spring Hill Street, which is 30 feet wide.

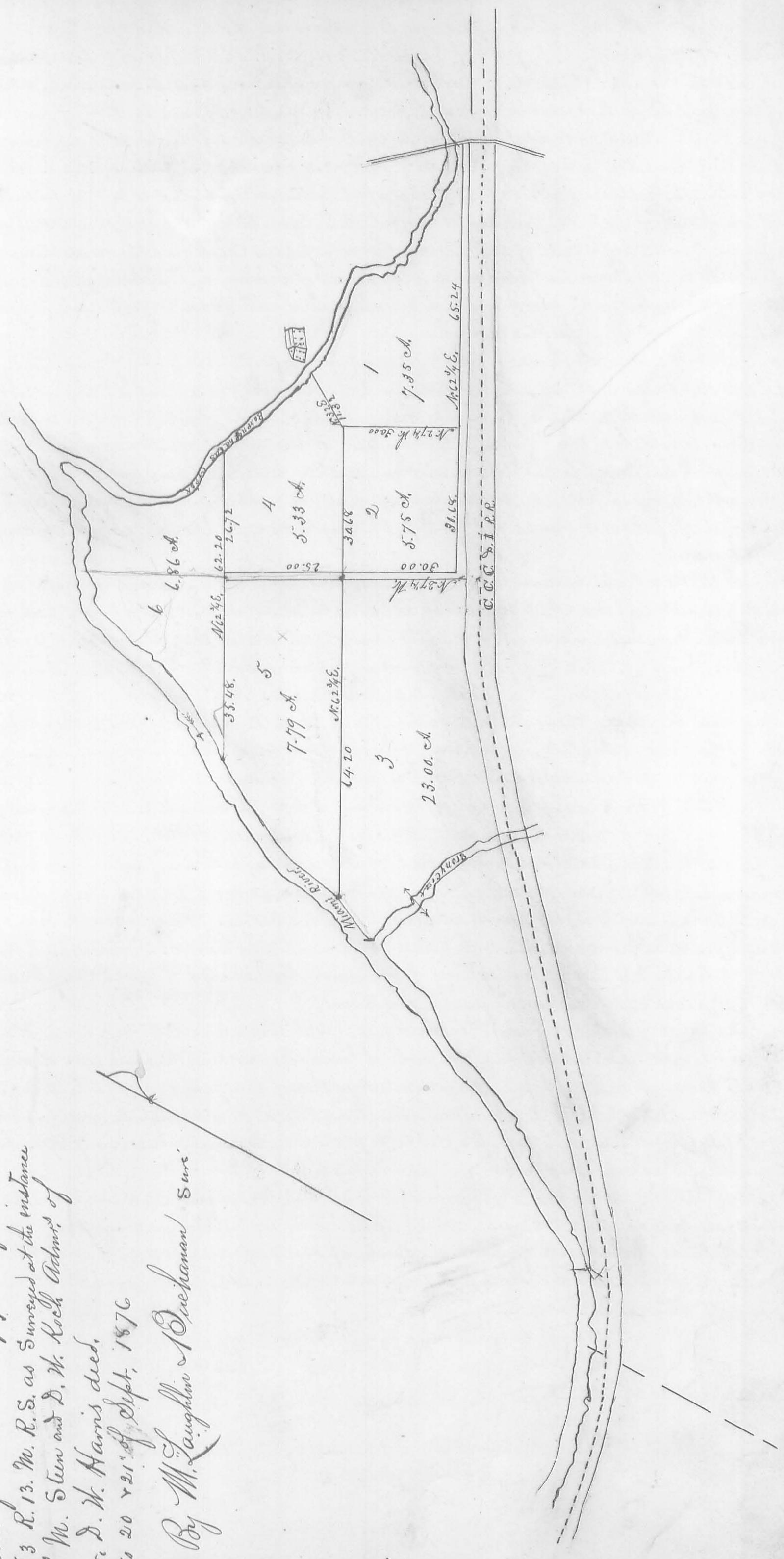
