

Costin - Gross Survey Bellefontaine August 1961 0.40 acre

Beginning at an iron at the S.W. corner of Lot Number 3532. Thence with the east side of Marion D. Wagner's 0.65 acre tract and with the east side of Orrie J. Costin's present 0.40 acre tract S. 3 - 37 W. 70.60 feet to an iron. Said iron being at the S.E. corner of said Orrie J. Costin's present 0.40 acre tract and the N.E. corner of Fred Gross's present 0.78 acre tract. Said iron being the beginning point of this survey.

Thence S. 89 - 17 E. 268.00 feet to an iron in the west line of Archie Gillespie's 3.15 acre tract.

Thence with the west side of said Gillespie's 3.15 acre tract S. 5 - 50 W. 84.80 feet to an iron in the north line of Archie Gillespie's 2.99 acre tract.

Thence with the north side of said Gillespie 2.99 acre tract N. 86 - 05 W. 264.50 feet to an iron at said Gillespie's N.W. corner and in the east line of Fred Gross's present 0.78 acre tract.

Thence with the east side of said Gross's present 0.78 acre tract N. 3 - 28 E. 70.00 feet to the place of beginning.
