Commencing at a found 5/8 inch diameter iron rod marking the northwest corner of said Lot 3865 and the northeast corner of Lot 3864 and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence on an assumed bearing of N 55° 49' 17" E along the right of way of Knowlton Road a distance of 112.00 feet to a point;

thence S 34° 16' 22" E on a line a distance of 199.94 feet to a set iron rod marking the north line of a 4.951 acre parcel of land now or formerly owned by William L. Fraim, Trustee (O.R. 1023, Pg. 312), passing a set iron rod a distance of 3.00 feet;

thence S 55° 54' 06" W a distance of 112.00 feet along said William L. Fraim, Trustee (O.R. 1023, Pg. 312) parcel and a 0.183 acre parcel of land now or formerly owned by Joanne H. Ritter Trustee (O.R. 786, Pg. 576) to a found 5/8 inch diameter iron rod marking the southwest corner of said Lot 3865, passing a found 5/8 inch diameter iron rod a distance of 96.40 feet;

thence N 34° 16' 22" W along the west line of said Lot 3865 and the east line of said Lot 3864 a distance of 199.78 feet to the **POINT OF BEGINNING.**

Containing in all 0.514 acres of land, more or less. The above described property being subject to all legal highways and easements of record.



thence on an assumed bearing of S 55° 54' 06" W along the southerly line of said Lots 3865 and 3866 and the north line of a 4.951 acre parcel now or formerly owned by William L. Fraim, Trustee, (OR 1023, Page 312) a distance of 127.55 feet to a found 5/8 inch diameter iron rod;

thence N 34° 16' 22" W on a line a distance of 10.00 feet to a set iron rod;


