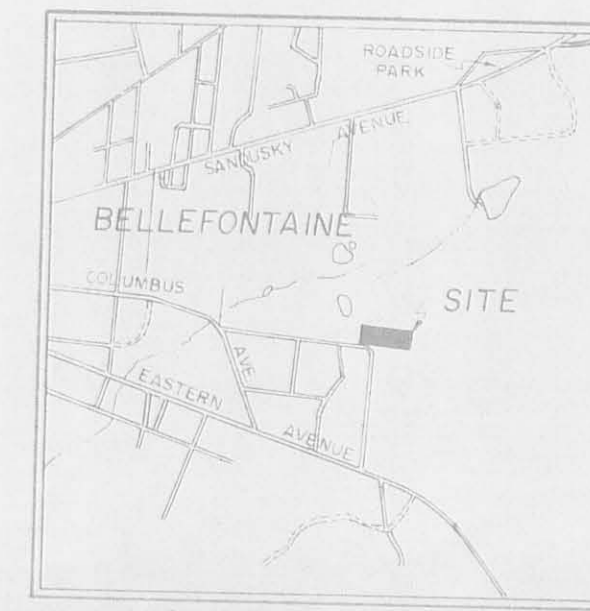

BEGINNING AT THE INTERSECTION OF THE NORTH LINE OF RESERVOIR ROAD WITH THE WEST LINE EXTENDED OF LOT 4128 AS PLATTED IN HUMBLE ALLOTMENT NO. 2; THENCE N. 84°-00'-57" W. ALONG THE NORTH LINE OF RESERVOIR ROAD FOR 207.30 FEET; THENCE N. 76°-24'-51" W. FOR 75.59 FEET; THENCE N. 6°-24'-03" E. FOR 190.00 FEET; THENCE S. 84°-00'-57" E. FOR 509.00 FEET; THENCE S. 6°-24'-03" W. FOR 200.00 FEET TO THE NORTH LINE OF RESERVOIR ROAD; THENCE N. 84°-00'-57" W. ALONG SAID NORTH LINE FOR 226.70 FEET TO THE PLACE OF BEGINNING
