Lying in Section 34, Town 4, Range 14, City of Bellefontaine, Lake Township, Logan County, Ohio.

Being all of that tract in the name of M & B Investments as deeded and described in Official Record 136, Page 185 of the Logan County Records of Deeds and being more particularly described as follows:

Beginning at a 5/8 inch iron rod found at the intersection of center-lines of Troy Road and Plumvalley Street.

THENCE, with the center-line of Troy Road (60 feet wide), N 4°-21'-20" E, a distance of 598.02 feet to a railroad spike found.

THENCE, S 85°-46'-01" E, a distance of 30.00 feet to a 3/4 inch iron rod set on the east right-of-way of Troy Road at the TRUE POINT OF BEGINNING.

THENCE, with the right-of-way of Troy Road, N 4°-21'-20" E, a distance of 100.00 feet to a 3/4 inch iron rod set.

THENCE, with a north line of the City of Bellefontaine and the south line of the Dane Taylor 52.83 acre tract (O.R. 16, Pg. 804), S 85°-46'-01" E, a distance of 1421.36 feet to a 3/4 inch iron rod set on the westerly right-of-way of Plumvalley Street (60 feet wide).

THENCE, with the westerly and northerly right-of-way of Plumvalley Street the following eight courses:

S 21°-43'-42" W, a distance of 64.22 feet to a 3/4 inch iron rod set.

S 40°-36'-45" W, a distance of 82.12 feet to a 3/4 inch iron rod set.

S $76^{\circ}-30'-45"$ W, a distance of 123.12 feet to a 3/4 inch iron rod set. S $54^{\circ}-49'-56"$ W, a distance of 202.18 feet to a 3/4 inch iron rod set.

S 32°-17'-54" W, a distance of 135.12 feet to a 3/4 inch iron rod set. N 83°-07'-54" W, a distance of 324.08 feet to a 3/4 inch iron rod set.

S 82°-34'-11" W, a distance of 340.88 feet to a 3/4 inch iron rod set.

S $67^{\circ}-20'-00"$ W, a distance of 189.71 feet to a 3/4 inch iron rod set.

THENCE, with the east line of the Grace Ross 3.00 acre tract (Vol. 394, Pg. 541), N 4°-21'-20" E, a distance of 452.25 feet to a 3/4 inch iron rod set.

THENCE, with the north line of the said 3.00 acre tract, N 85°-46'-01" W, a distance of 190.70 feet to the point of beginning.

Containing 10.577 acres.

The basis for bearings is based upon the center-line of Plumvalley Street at the intersection with Troy Road being S 67°-20'-00" W, and all other bearings are from angles and distances measured in a field survey by Lee Surveying and Mapping Company in September 1991.


