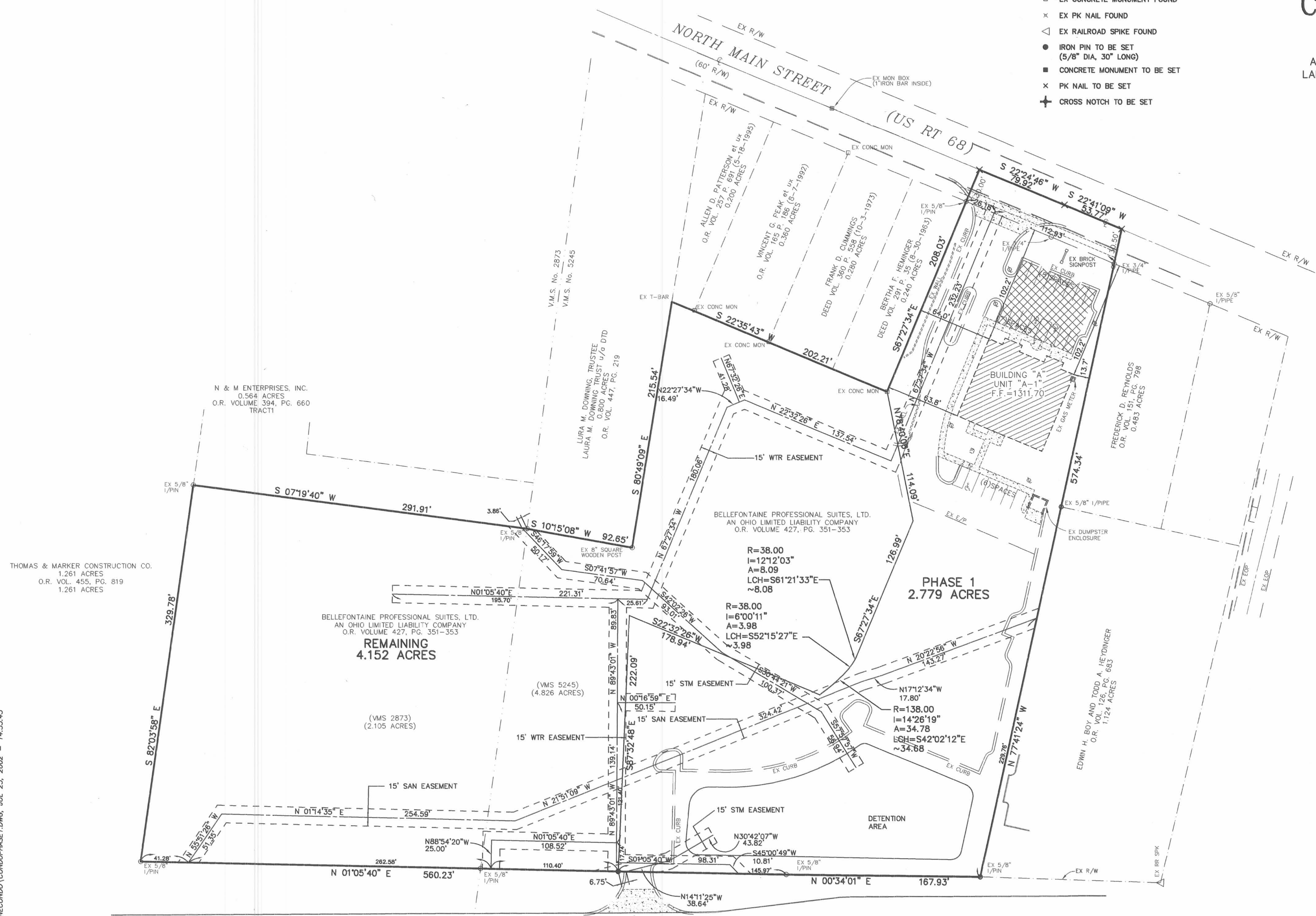

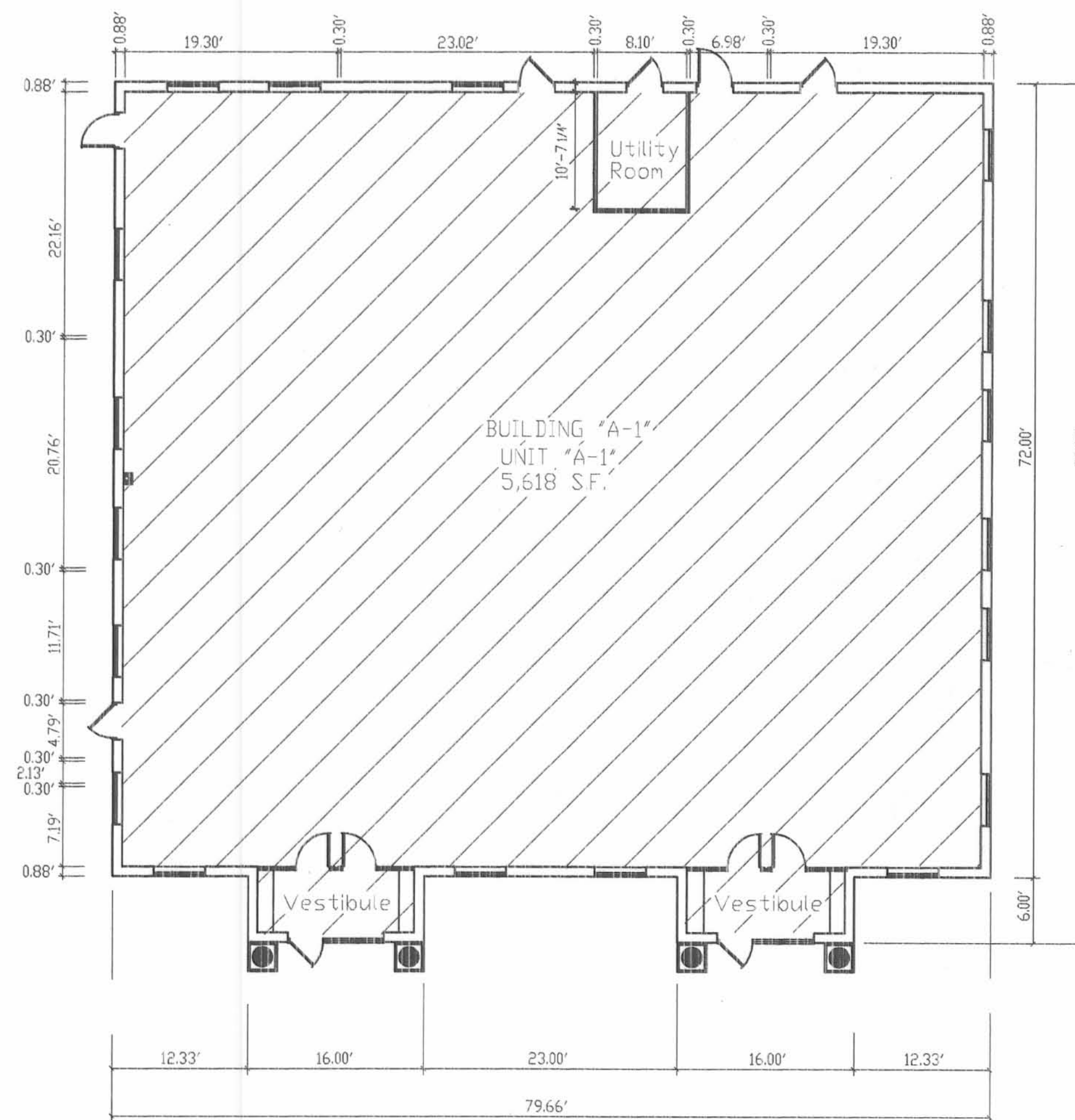

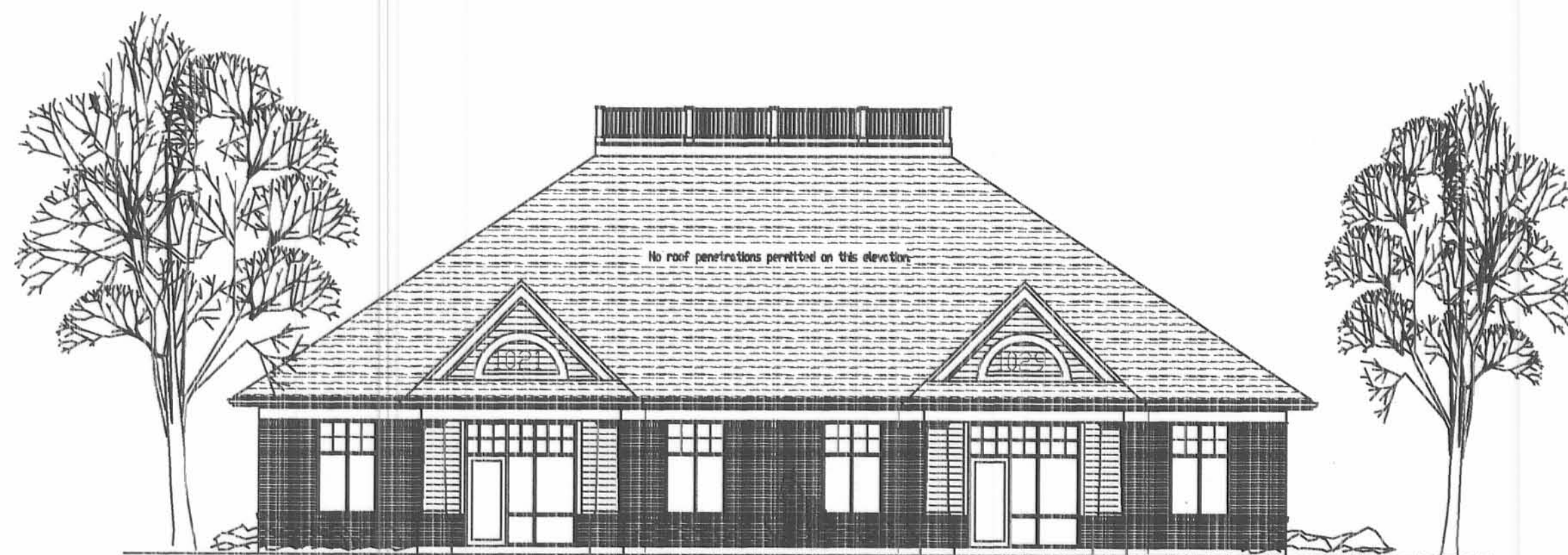

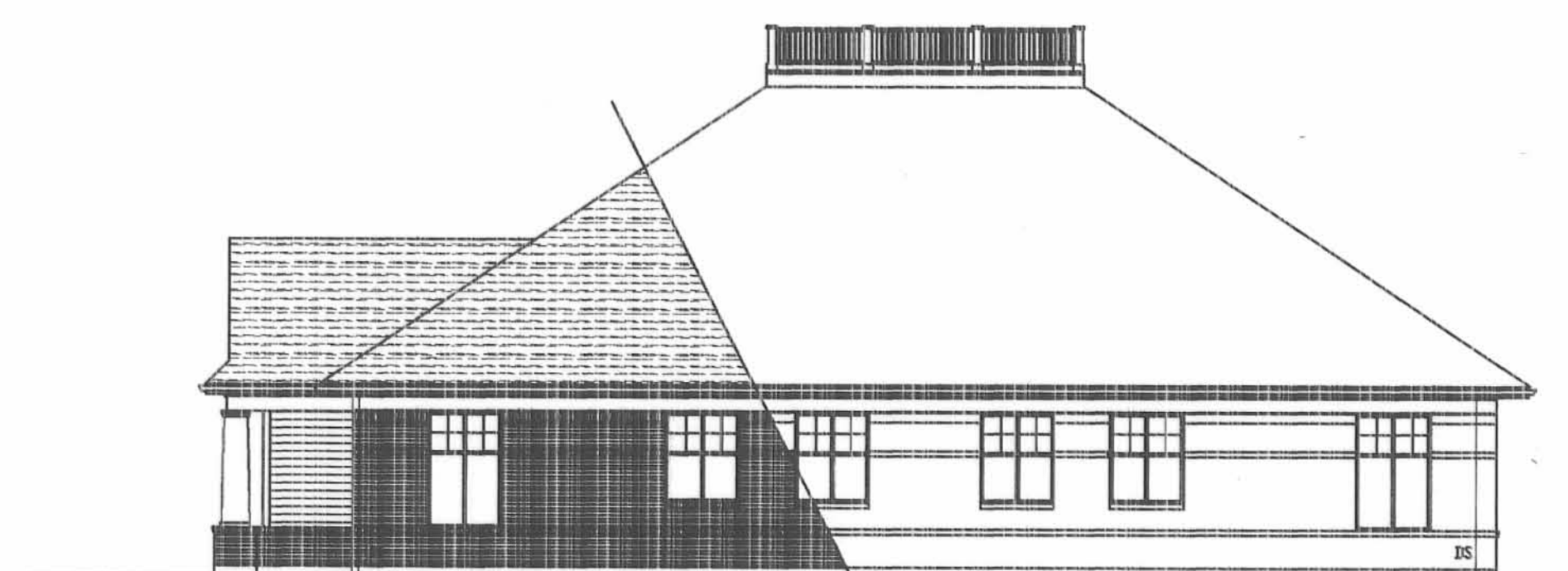
BUILDING "A" FLOOR PLAN
