LEGAL DESCRIPTION - 1125 NORTH MAIN CARWASH -0.705 ACRE

Being situate in the State of Ohio, County of Logan, City of Bellefontaine, Lake Township, and being a part of Virginia Military Survey 2873, and being more particularly described as follows:

Beginning for reference at a ¾" diameter iron pipe in a monument box found at the intersection of the centerlines of Dowell Ave. (40' right-of-way) and N. Main Street (aka, US. Route 68) (60' right-of-way), also being on the South line of V.M.S. 2873, and the North line of V.M.S. 5245;

Thence with the centerline of N. Main Street, N-17°12′56″-E, 271.43′(feet) to a Mag Nail set at the **PRINCIPLE PLACE OF BEGINNING** for the tract hereinafter described, also being at the Northeast corner of a 0.50 acre tract conveyed to Tonia E. Terebuh, Trustee, by deed recorded in Official Record 305, Page 559, Tract III;

Thence with the North line of the 0.50 acre tract, N-86°56′14″-W, 341.65′(feet) to a 5/8″ diameter iron bar found on an East line of a 1.999 acre tract conveyed to CRE8IVE Hospitality, LLC, by deed recorded in Official Record 1275, Page 660, passing for reference a 5/8″ diameter iron bar found on the right-of-way line of N. Main Street at 30.94′(feet);

Thence with an East line of the 1.999 acre tract and with the East line of a 1.261 acre tract conveyed to HI-POINT Graphics, LLC, by deed recorded in Official Record 1397, Page 2258, N-2°11′55″-E, 111.50′(feet) to a 5/8″ diameter iron bar found at the Southwest corner of a 2.599 acre tract conveyed to Golden Arch Limited Partnership by deed recorded in Official Record 266, Page 161, passing for reference a 1″ diameter iron bar found at 22.27′(feet);

Thence with the South line of the 2.599 acre tract, S-79°12′14″-E, 362.44′(feet) to a Mag Nail set on the centerline of aforementioned N. Main Street, passing for reference an iron bar set on the right-of-way line of N. Main Street at 332.25′(feet);

Thence with the centerline of N. Main Street, S-17°12'56"-W, 64.68'(feet) to the place of beginning.

Containing 0.705 acre, 0.048 acre of which is within the Road right-of-way, but being subject to the rights of all legal highways and all easements of record.


