THENCE, S 05°-22'-28"E, a distance of 478.80 feet to a 5/8 inch iron rod set, passing a 5/8 inch iron rod set at 30.00 feet.

THENCE, S 83°-26'-45"W, a distance of 182.00 feet to a 5/8 inch iron rod set.

THENCE, N 05°-22'-28"W, a distance of 478.80 feet to the point of beginning, passing a 5/8 inch iron rod set at 448.80 feet.

Containing 2.000 acres, of which 0.125 acre is within the highway right-of-way.

The basis for bearings is the center-line of County Highway 48, being N 83°-26'-45"E, and all other bearings are from angles and distances measured in a field survey by Lee Surveying and Mapping Co., Inc. on October 24, 2008.



Commencing at the south easterly corner of V.M.S. 9938, the north easterly corner of V.M.S. 9913, the south westerly corner of V.M.S. 10060 and the north westerly corner of V.M.S. 9914, also being at the intersection of the centerlines of County Road 48 (60 foot Right of Way) and County Road 120 (30 foot Right of Way), at a Monument Box Found with a ½" Iron Pin Found inside;

thence with the centerline of said C.R. 48, also being in V.M.S. line between said V.M.S. 10060 and 9914, N84°08'41"E, a distance of 1690.17 to a **Rail Road Spike Set**, in said forementioned line; also being the north easterly corner of a 1.85 acre tract in the name of Dewayne E. Prater recorded in Official Record 181, Page 534, also being **THE TRUE POINT OF BEGINNING**;

thence continuing with said centerline and said V.M.S. line, N84°08'41"E, 545.77 feet, to a Rail Road Spike Found, in said centerline and said V.M.S. line, also being the north westerly corner of a 2.00 acre tract of land in the name of John E. and Kimberly Hoagland, recorded in O.R. 1333, page 392;

thence with the westerly line of said 2.00 acre tract **S04°40'36"E**, (passing through a 5/8" Iron Pin Found at 29.93 feet), a total distance of **478.77 feet** to a **5/8" Iron Pin Found**, at the southwesterly corner of said 2.00 acre tract;

thence with the southerly line of said 2.00 acre tract, **N84°08'37"E**, **182.00 feet**, to the south easterly corner of said 2.00 acre tract, at a **5/8" Iron Pin Found**, (stamped "Lee");

thence with the easterly line of said 2.00 acre tract, **N04°40'41"W**, (passing through a 5/8" Iron Pin Found at a distance of 448.77), a total distance of **478.76 feet**, to the north easterly corner of said 2.00 acre tract, at a **Rail Road Spike Found**, in the centerline said C.R. 48, also being in V.M.S line between said V.M.S. 10060 and 9914;

thence with said centerline and V.M.S. line, N84°08'41"E, 889.19 feet, to a Rail Road Spike Set, in said forementioned line, where they intersect the rail road right of way for the Toledo and Ohio Central Railway Company, found in Deed Book 81, page 430, also recorded on rail road valuation map R-35;

thence with the western Right of Way of said rail road, \$05°02'38"E, (passing through a 8" wood post at a distance of 28.22 feet), a total distance of 2360.86 feet, to an Iron Pin Set, also being the north easterly corner of a 59.62 acre tract land in the name of Cronkleton Land LLC, found as parcel 4, tract 3 in O.R. 1319, page 634, a stone was found approximately 806.74 feet, \$04°34'22"E of said Iron Pin Set, which was utilized to determine the location for setting the Iron Pin by comparing distance, not direction;

thence with the northerly line of said 59.62 acre tract **S84°15'33"W**, **1587.74** feet, to an **Iron Pin Set**, at the south easterly corner of a 38.15 acre tract in the name of Cronkleton Land LLC, found as parcel 4, tract 2 in O.R. 1319, page 634;

thence with the easterly line of said 38.15 acre tract and the easterly line of said 1.85 acre tract, N05°45'10"W, (passing through a 5/8" Iron Pin Found at a distance of 2099.64 and a 8" wood post found at a distance of 2327.53), a total distance of 2357.45 feet, back to THE TRUE POINT OF BEGINNING;

Containing 84.777 acres, with 0.988 acres in the road Right of Way for said C.R. 48 more or less, however subject to all legal road right of way and prior easements of record. All Iron Pins Set are 5/8" inch diameter and 30" long with a pink cap stamped "Grand Lake P.S. 8468". This description was written from an actual field survey in July of 2024 by Grand Lake Surveying LLC. Bearings are based on Ohio State Plane NAD 83 South Zone VRS (2011) Scaled to the ground at 0,0 with a scale factor of 1.0000520759.


