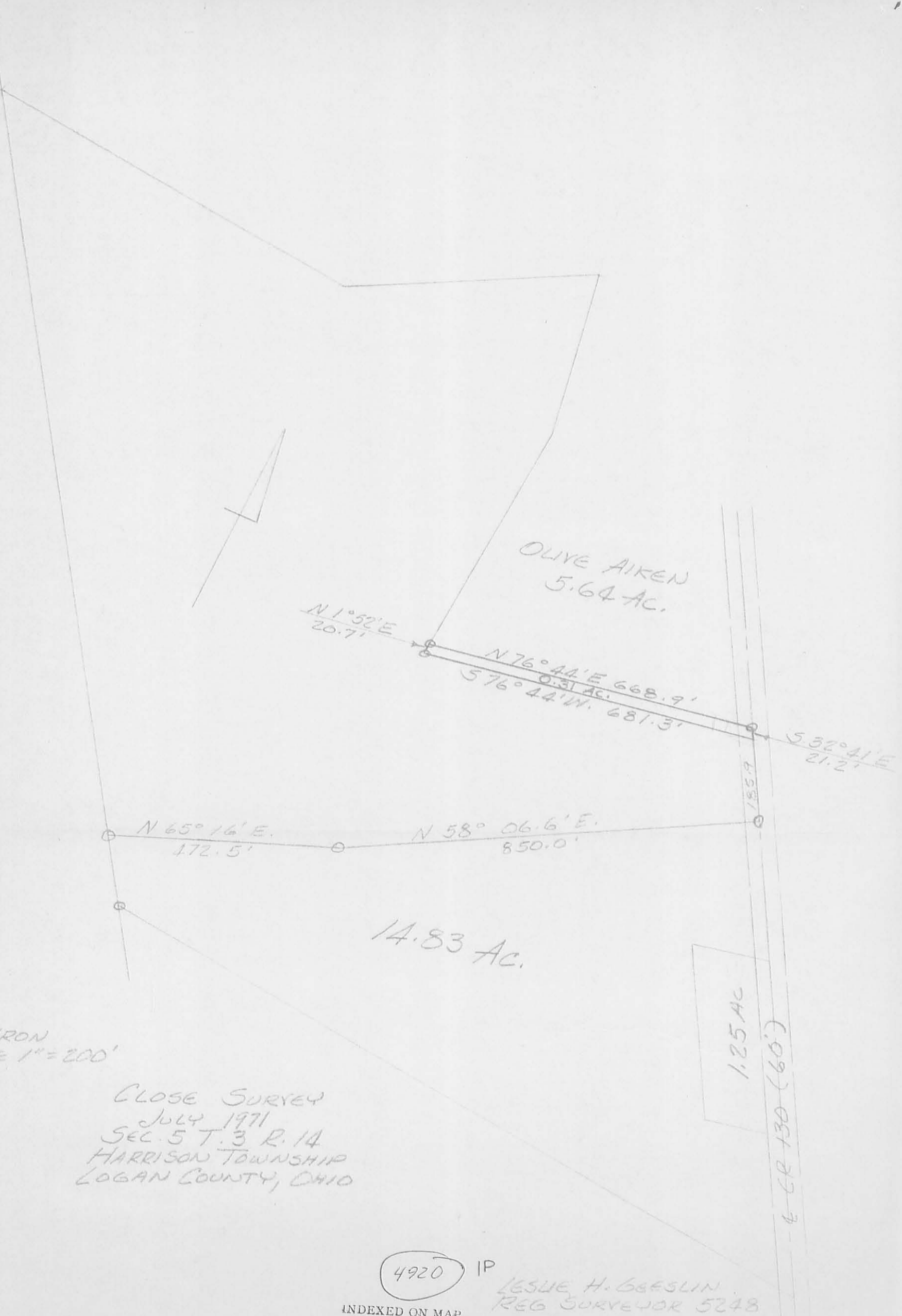

Containing 0.31 acres, more or less.

Bridge 130-1.43 Permanent Easement for Road Maintenance Purposes

The following described Permanent Easement for Road Maintenance Purposes is situated in Harrison Township, Logan County, Ohio and is part of the N.E. quarter of Section 5, Town 3, Range 14. of the Between the Miami Rivers Survey. Said permanent easement being part of Beverly J. Mellum's 28.90 acre tract, (O.R. Vol. 393; pg.992, tract 1) carried as parcel number 08-077-00-00-071 on the Logan County Auditors Duplicate and is more particularly described as follows:

Beginning for reference at a Mag Nail Set on the centerline of Logan County Road No. 130. Said Mag Nail being at Logan County Road No. 130 centerline station 0+00 (ref. R/W Plans L-27).

Thence with the centerline of Logan County Road No. 130, North 30°-00'-00" West, 953.00 feet to a point at station 9+53.00.

Thence perpendicular to the centerline of Logan County Road No.130, South 60°-00'-00" West, a distance of 30.00 feet to a point on the west Right of Way line of Logan County Road No. 130. Said point being the true point of beginning for this easement description.

Thence continuing, South 60°-00'-00" West, a distance of 22.00 feet to a point, said point being 52.00 feet left of Logan County Road No. 130 centerline station 9+53.00:

Thence parallel to the centerline of Logan County Road No. 130, North 30°- 00'-00" West a distance of 44.00 feet to a point, said point being 52.00 feet left of Logan County Road 130 centerline station 9+97.00;


Thence perpendicular to the centerline of Logan County Road No. 130, North 60°-00'-00" East, a distance of 22.00 feet to a point on the west Right of Way line of Logan County Road No. 130. Said point being 30.00 feet left of Logan County Road No. 130 centerline station 9+97.00:

Thence with the west Right of Way line of Logan County Road No. 130 South 30°- 00'-00" East a distance of 44.00 feet to the Point of beginning.

Said Permanent Easement for Road Maintenance Purposes contains 0.022 acres or 968.00 square feet more or less.

Basis of Bearing being the centerline of Logan County Road No. 130 (North 30°-00'-00" West) as shown on the Right of Way Plans L-27, filed in the Map Room of the Logan County Engineer's Office.

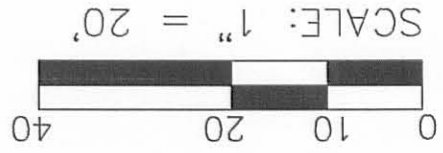
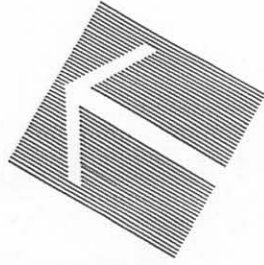

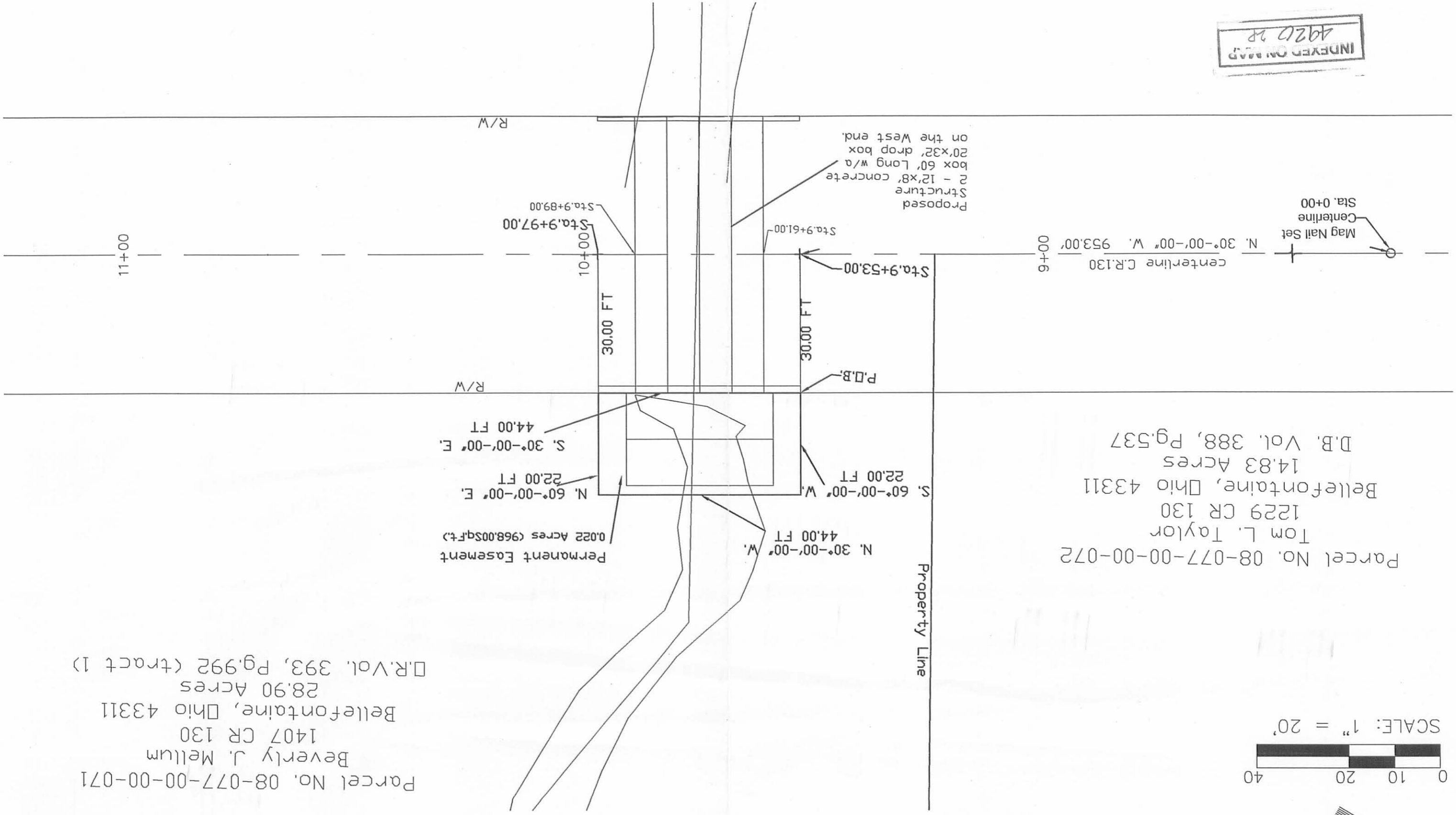
