

Knights of Pythias

The following described real estate situated in the Village of Huntsville, Township of McArthur, County of Logan, State of Ohio and being a part of Virginia Military Survey No. 9904 and being more particularly described as follows:

Beginning at the southeast corner to the present brick building (known as the Knights of Pythias hall), said corner being in the west right of way line of the C. C. C. & St. L. RR. (now Penn Central) and the north line of Napoleon Street;

Thence with the north line of Napoleon Street, N. $73^{\circ} 22'$ W. 34.05 feet to an iron pipe, southeast corner to Lulu P. Roldan's present 0.10 Acre tract, said iron pipe being S. $73^{\circ} 22'$ E. 45.80 feet from an iron bar at the intersection of the north line of Napoleon Street and the east line of Wishart Street;

Thence with the east line of Roldan's tract, N. $17^{\circ} 00'$ E. 70.20 feet to an iron pipe, said iron pipe being N. $73^{\circ} 06'$ W. 3.00 feet from the northwest corner to said brick building;

Thence with the north line of Roldan's tract, N. $73^{\circ} 06'$ W. 78.00 feet to an iron pipe in the east line of Wishart Street, said iron pipe being N. $7^{\circ} 35'$ W. 77.35 feet from an iron bar at the intersection of the east line of Wishart Street and the north line of Napoleon Street;

Thence with the east line of Wishart Street, N. $7^{\circ} 35'$ W. 33.35 feet to an iron bar at the southwest corner to Byron O. Youtsey's 0.07 Acre tract;

Thence with the south line of Youtsey's tract, S. $73^{\circ} 23'$ E. 100.70 feet to an iron bar, southeast corner to Youtsey and being in the west line of a tract belonging to Darwin H. Crefut;

Thence with Crefut's west line, S. $17^{\circ} 01'$ W. 3.90 feet to an iron bar, Crefut's southwest corner;

Thence with Crefut's south line, S. $73^{\circ} 51'$ E. 25.01 feet to an iron bar in the west right of way line of the C. C. C. & St. L. RR. (now Penn Central), said iron bar being Crefut's southeast corner;

Thence with the west right of way line of the C. C. C. & St. L. RR. (now Penn Central), S. $16^{\circ} 52'$ W. 97.31 feet to the place of beginning, passing the northeast corner to said brick building at 27.01 feet, containing 0.136 Acres, more or less.
