Beginning at a PK nail found on the west line of the said 108.51 acre tract, the east line of the Harold D. Marker, etal original 123.24 acre tract (O.R. 97, Pg. 283, Tr. III), the center-line of Township Road 183, and a southeast corner of the present corporation line of the City of Bellefontaine (Plat Cabinet 'A', Slide 729).

THENCE, with the east line of the said 123.24 acre tract and the said east corporation line, N 5°-46'-40" W, a distance of 2684.56 feet to a 1 inch metal pipe found.

THENCE, with the south line of the Harold D. Marker, etal original 93.204 acre tract (O.R. 65, Pg. 582), N 85°-02'-25" E, a distance of 200.02 feet to a 5/8 inch iron rod set.

THENCE, S 5°-46'-40" E, a distance of 2683.20 feet to a railroad spike set, passing a 5/8 inch iron rod set at 2663.20 feet.


THENCE, with the center-line of Township Road 183 (variable width), S 84°-38'-59" W, a distance of 200.01 feet to the point of beginning.

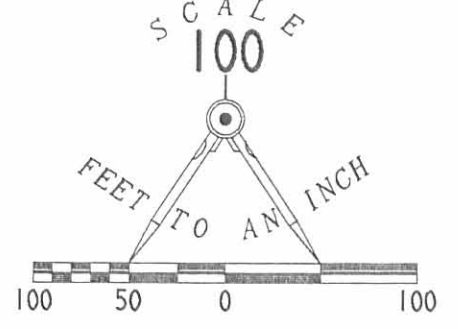

III), the center-line of Township Road 183, and a southeast corner of the present corporation line of the City of Bellefontaine (Plat Cabinet 'A', Slide 729).

THENCE, with the center-line of Township Road 183, N 84°-38'-59" E, a distance of 200.01 feet to a railroad spike set at the TRUE POINT OF BEGINNING.

THENCE, with the east line of the Harold D. Marker 12.323 acre tract (O.R. 248, Pg.620), N 5°-46'-40" W, a distance of 2683.20 feet to a 5/8 inch iron rod set, passing a 5/8 inch iron rod set at 20.00 feet.

THENCE, with the south line of the Harold D. Marker, etal original 93.204 acre tract (O.R. 65, Pg. 582), N 85°-02'-25" E, a distance of 400.04 feet to a 5/8 inch iron rod set.

THENCE, S 5°-46'-40" E, a distance of 2542.17 feet to a railroad spike set, passing a 5/8 inch iron rod set at 2518.27 feet.

THENCE, with the center-line of Township Road 183 (40 feet wide) the following two courses:

S 51°-02'-08" W, a distance of 249.82 feet to a 5/8 inch iron rod found.

S 84°-38'-59" W, a distance of 190.93 feet to the point of beginning.



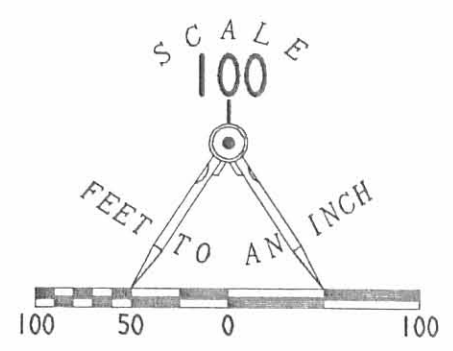

WHILAMENE GODWIN SURVEY

Lying in V.M.S. 3683, in both Lake and Jefferson Townships, Logan County, Ohio.

Being that same land, after exceptions, in the name of Whilamene Godwin as deeded and described in Volume 203, Page 203 of the Logan County Records of Deeds and includes all remaining parts of Tracts 1, 2, 3, and 4 as described therein. The boundary of said remaining land being more particularly described as follows:

Beginning at a 5/8" iron rod set on the center-line of Township Road 183, marking the south-east corner of the Traul lands (Volume 328, Page 702 and Volume 362, Page 315).

THENCE, with the west line of the Godwin land, the same being the east line of the said Traul land, N 5°-46'-40" W, 2684.35 feet to a 1" iron pipe found at the southwest corner of the Devine property (Volume 266, Page 280).

THENCE, with the south line of said Devine land, N 85°-02'-25" E, 1785.91 feet to a 1" iron pipe found at the northwest corner of the Whitney Partnership 20 acre tract (Volume 394, Page 420).

THENCE, with the west line of said 20 acre tract, S 4°-43'-50" E, 1736.50 feet to a 1" iron pipe found on the center-line of an abandoned road.

THENCE, with said center-line and property line, S 49°-27'-15" W, 716.77 feet to a 5/8" iron rod.

THENCE, with the west line of the Joseph Wilgus original 44.48 acres (Volume 200, Page 559) and the west line of the Hi-Point Church of Christ 4.145 acre tract (Volume 384, Page 824) the following 3 bearings and distances:

S 4°-44'-35" E, 535.35 feet to a 1" iron pipe (found).

S 85°-37'-15" W, 242.99 feet to a 1" iron pipe found on the west line of Township Road 183.

S 6°-12' E, with the said east road line, 801.84 feet to a 5/8" iron rod.

THENCE, S 61°-59' W, 24.66 feet to a 5/8" iron rod on the north property line of the State of Ohio 31 acre tract (Volume 304, Page 603).

THENCE, with the said north property line of the said 31 acre tract, the following 7 bearings and distances:

N 28°-08'-20" W, 375.00 feet to a 5/8" iron rod.

N 72°-05'-10" W, 346.58 feet to a 5/8" iron rod.

N 87°-17'-30" W, 503.38 feet to a 5/8" iron rod.

N 74°-05'-30" W, 246.16 feet to a 5/8" iron rod.

N 6°-05'-15" W, 137.40 feet to a chiseled cross on a post base at the south line of Township Road 183.

N 84°-38'-40" E, 200.20 feet to the east end of the limited access of Township Road 183.

N 5°-21'-45" W, 40.03 feet to the center-line of Township Road 183.

THENCE, with said center-line, N 84°-38'-15" E, 91.18 feet to the point of beginning.

Containing 108.51 acres, of which 16.80 acres are in Lake Township and 91.71 acres are in Jefferson Township.

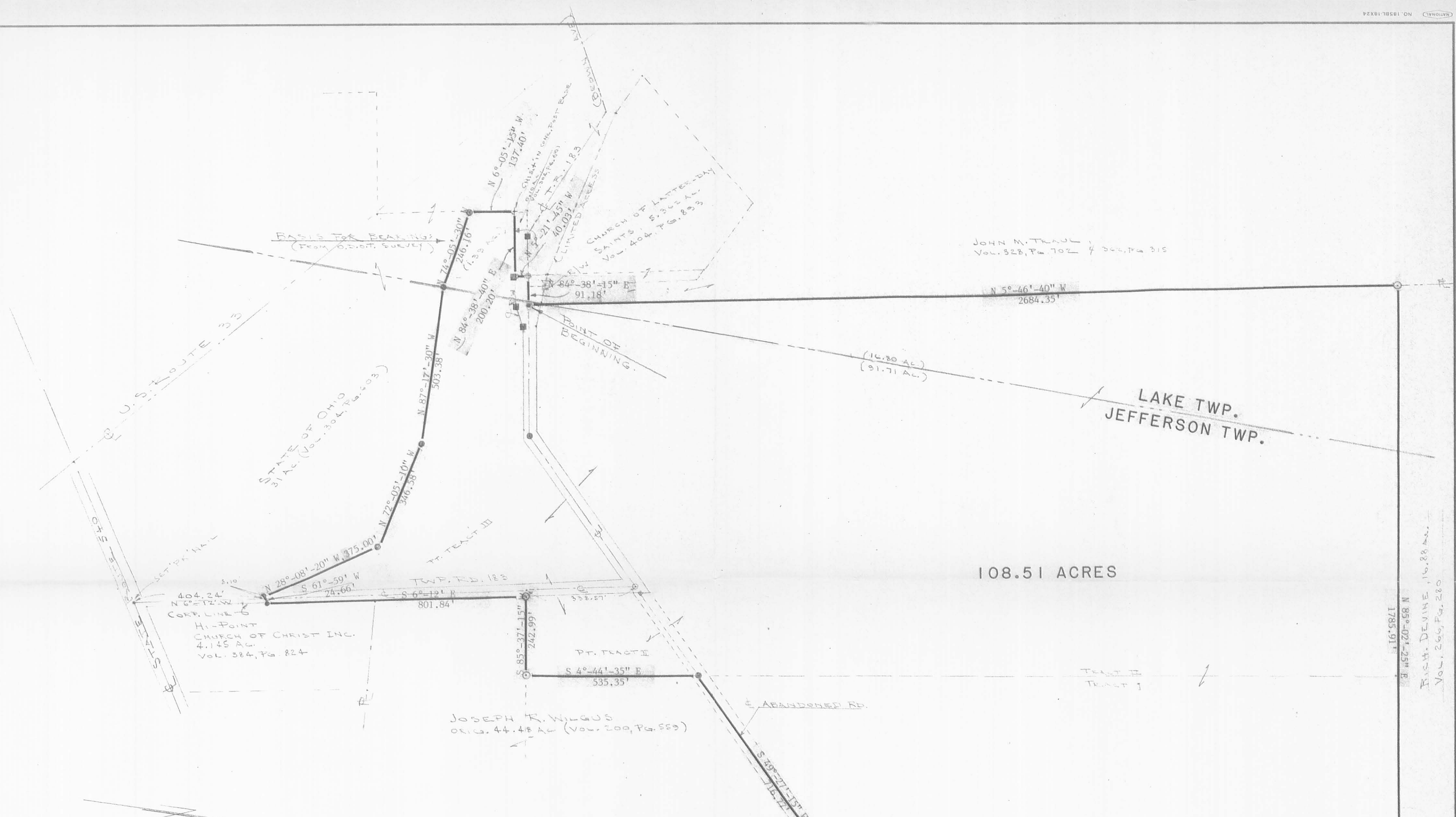
