DONALD VANCE (10.049 ACRES)

Lying in V.M.S. 4948 and V.M.S. 12563, Jefferson Township, Logan County, Ohio.

Being out of the Donald E. Vance 20.0 acre tract as deeded and described in Volume 402, Page 481 of the Logan County Records of Deeds and being more particularly described as follows:

Beginning at a 1/2 inch iron rod found at center-line station 149+55.6 of County Highway 10 as noted in the Logan County Engineer's Field Book 615, Page 16.

THENCE, with the center-line of County Highway 10, N 85°-38'-06" E, a distance of 232.62 feet to a railroad spike set at the TRUE POINT OF BEGINNING.

THENCE, 60.00 feet westerly at right angles and parallel with the easterly line of the said 20.0 acre tract, N $14^{\circ}-39^{\circ}-22$ " W, a distance of 725.07 feet to a 3/4 inch iron rod set.

THENCE, S $86^{\circ}-42^{\circ}-00^{\circ}$ W, a distance of 614.60 feet to a 3/4 inch iron rod set on the westerly line of the said 20.0 acre tract and the center-line of a thirty foot wide lane.

THENCE, with the easterly line of the United Presbyterian Church 108.85 acre tract (Vol. 269, Pg. 536), N 18°-22'-05" W, a distance of 582.86 feet to a 3/4 inch iron rod set at the northwest corner of the said 20.0 acre tract.

THENCE, with the north and easterly lines of the said 20.0 acre tract and the lines of the Lena Comer 185.56 acre tract (Vol. 304, Pg. 818), the following four courses:

N 67°-55'-14" E, a distance of 483.96 feet to a 3/4 inch iron rod set.

S 22°-24'-39" E, a distance of 243.93 feet to a 3/4 inch iron rod set.

S 49°-02'-54" E, a distance of 331.92 feet to a 3/4 inch iron rod set.

S $14^{\circ}-39'-22"$ E, a distance of 985.55 feet to a railroad spike set on the center-line of County Highway 10.

THENCE, with the center-line of County Highway 10, S 85°-38'-06" W, a distance of 60.98 feet to the point of beginning.

Lying in V.M.S. 4948 and V.M.S. 12563, Jefferson Township, Logan County, Ohio.

Being out of the Donald E. Vance 20.0 acre tract as deeded and described in Volume 402, Page 481 of the Logan County Records of Deeds and being more particularly described as follows:

Beginning at a 1/2 inch iron rod found at center-line station 149+55.6 of County Highway 10 as noted in the Logan County Engineer's Field Book 615, Page 16.

THENCE, with the center-line of County Highway 10, S 86°-42'-00" W, a distance of 400.51 feet to a railroad spike set at the southwest corner of the said 20.0 acre tract.

THENCE, with the west line of the said 20.0 acre tract, the center-line of a thirty foot wide lane and the east line of the United Presbyterian Church 108.85 acre tract (Vol. 269, Pg. 536), N 9°-13'-51" W, a distance of 415.10 feet to a 3/4 inch iron rod set on the line between V.M.S. 4948 and V.M.S. 12563.

THENCE. continuing with the center-line of the lane and the said 108.85 acre tract, N 18°-22'-05" W, a distance of 313.08 feet to a 3/4 inch iron rod set.

THENCE, through the said 20.0 acre tract, N 86°-42'-00" E, a distance of 614.60 feet to a 3/4 inch iron rod set.

THENCE, 60.00 feet westerly at right angles and parallel with the easterly line of the said 20.0 acre tract, S 14°-39'-22" E, a distance of 725.07 feet to a railroad spike set on the center-line of County Highway 10.

THENCE, with the center-line of County Highway 10, S 85°-38'-06" W, a distance of 232.62 feet to the point of beginning.


