The following described land in the Village of Lakeview, Stokes Township, Logan County Ohio and being in Section 34 Town 6 Range 8 and being off the south part of a 0.47 acre tract and being more fully described as follows :

Beginning at an iron at the S.W. corner of a 0.47 acre tract in the name of John W. Mueller and at the S.E. corner of Edna E. Austin 0.39 acre tract

Thence with the east side of said Austin tract N. 7 - 02 E. 90.00 feet to an iron

Thence S. 87 - 25 E. 100.00 feet to an iron in the west side of Ethel and Charles E. White 0.68acre tract

Thence with the west side of said White land S. 7 - 02 W. 90.00 feet to an iron in the north line of H.W.Wise 0.80 acre tract

Thence with the north side of said Wise tract N. 87 - 25 W. 100.00 feet to the place of beginning. The last described line being the center of a thirty foot right of way known as Harrison Street extention.

Said described tract containing 0.20 of one acre.

The west ten feet of the above described 0.20 acre tract to be used by as a driveway for the adjoining property owners.

Thence again with the east side of said Austin land N. 7 - 02 E. 129.00 feet the last described line passing an iron on the south side of an open ditch at 125.00 feet

thence S. 73 - 30 E. 55.00 feet

Thence S. 11 - 20 E. 116.80 feet to an iron the last described line passing an iron on the south side of an open ditch at 4.00 feet

Thence N. 87 - 25 W. 45.00 feet to the place of beginning

Thence with the west side of said White land S. 7 - 02 W. 104.50 feet to an iron the last described line passing an iron at the south side of an open ditch at 4.00 feet

thence with the north side of a 0.20 acre tract N. 87 - 25 W. 55.00 feet to an iron at the S.E. corner of a 0.14 acre tract

Thence with the east side of said 0.14 acre tract N. 11 - 20 E. 116.80 feet the last described line passing an iron at the south side of an open ditch at 112.80 feet

Thence S. 73 - 30 E. 46.40 feet to the place of beginning

Said described tract containing 0.13 of one acre.

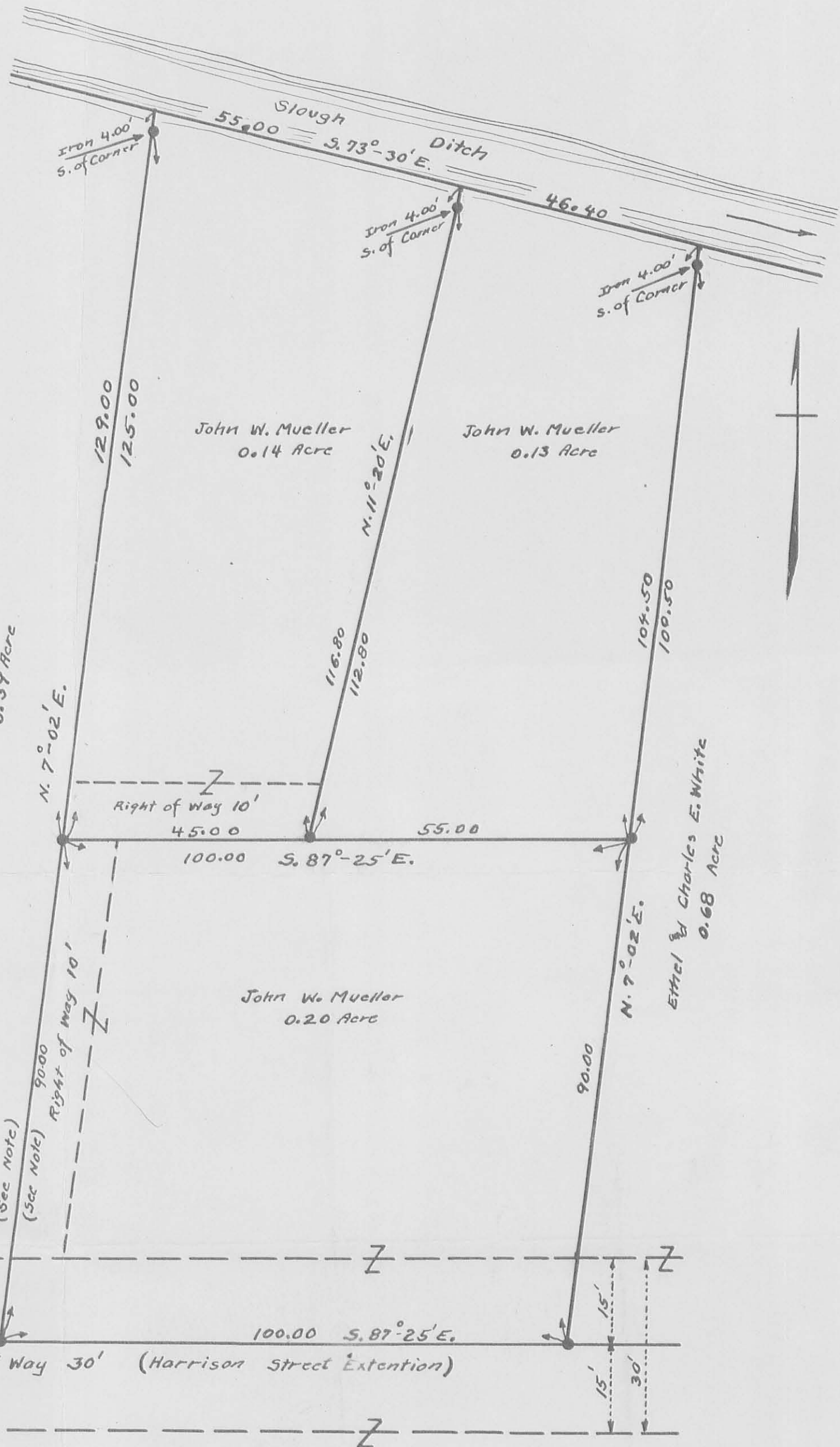
The described 0.13 acre to have the use for a driveway off of the south ten feet of the 0.14 acre tract which is west of the above described
