LEVAN TO STOTT SURVEY

Lying in Section 32, T-4, R-14, Liberty Township, Logan County, Ohio and being out of the 21.169 acre (Parcel 2) and the 0.58 acre (Parcel 3) deeded and described in Volume 368, Page 433 of the Logan County Records of Deeds and more particularly described as follows:

Beginning at the southwest corner of the said 21.169 acre tract in the east line of U.S. Route 68 (30 feet east of center-line) at an iron rod set 30 feet at right angles to State Highway Station 238+39.21.

THENCE, with said east line, N 4°-10' W, a distance of 238.00 feet to an iron rod set near the west end of an east-west fence.

THENCE, with said fence, N 89°-57' E, a distance of 828.50 feet to an iron rod.

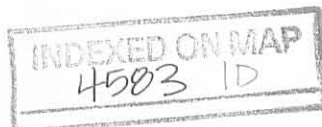
THENCE, parallel to the highway, S 4°-10' E, a distance of 289.14 feet to an iron rod set on the south line of said 21.169 acres. This point lying along said south line a distance of 286.1 feet westerly from a stone monument found on the east section line of Section 32 at the northeast corner of an 18.218 acre tract (Volume 368, Page 433, Parcel 1).

THENCE, with the north line of said 18.218 acres, N 86°-32'-30" W, a distance of 833.70 feet to the point of beginning. Containing 5.00 acres. (0.497 acre out of Parcel 3 and 4.503 acres out of Parcel 2).

LILE to LILE DESCRIPTION

SEPTEMBER, 1969

Being situated in Liberty Township, Logan County, Ohio; and being a part of Section 32, Town 4, Range 14.

Beginning at a iron in the east right of way line of State Route 68 (Bellefontaine and West Liberty Pike Road) that bears S $4^{\circ}-30'E$ *558.5 feet* from the northwest corner of F. Lile's 47.72 acre tract and 3001.0 feet from the north line of said Section 32.

Thence N $88^{\circ}-14'E$ 180.0 feet to a iron.

Thence S $4^{\circ}-30'E$ 140.0 feet to a iron.

Thence S $88^{\circ}-14'W$ 180.0 feet to a iron in the east right of way line of State Route 68.

Thence with said east right of way line of State Route 68 N $4^{\circ}-30'W$ 140.0 feet to the place of beginning.

Containing 0.58 of an acre more or less. Being surveyed from a 47.72 acre tract of which 19.17 acres are in Section 32.
