BAUMGARTNER SURVEY

Lying in the southeast quarter of Section 6, T-4, R-13, Liberty Township, Logan County, Ohio.

Being out of that 114.6 acres in the name of Baumgartner lying north of Township Road 30, (Volume 244, Page 38) and more particularly described as follows:

Beginning at a monument found on the center-line of Township Road 30, marking the southwest corner of said quarter section and the south west corner of said 114.6 acres and being on the west line of Liberty Township.

THENCE, with the center-line of Township Road 30, S 83°-45' E, a distance of 365.94 feet to a harrow tooth set for the TRUE POINT OF BEGINNING.

THENCE, at right angles, N 6°-15' E, a distance of 264.00 feet to an iron rod, passing an iron rod set on the north line of Township Road 30 at 20.00 feet.

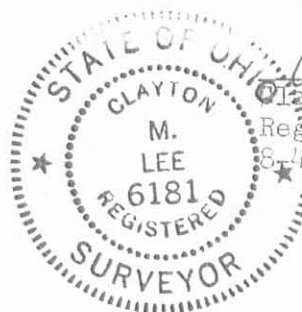
THENCE, again at right angles and parallel to the road, S 83°-45' E, a distance of 165.00 feet to an iron rod.

THENCE, parallel to the west line of this survey, S 6°-15' W, a distance of 264.00 feet to a harrow tooth set on the center-line of Township Road 30, passing an iron rod set on the north line of said road at 244.00 feet.

THENCE, with said center-line, N 83°-45' W, a distance of 165.00 feet to the point of beginning. Containing 1.00 acre.
