PROPERTY MAP

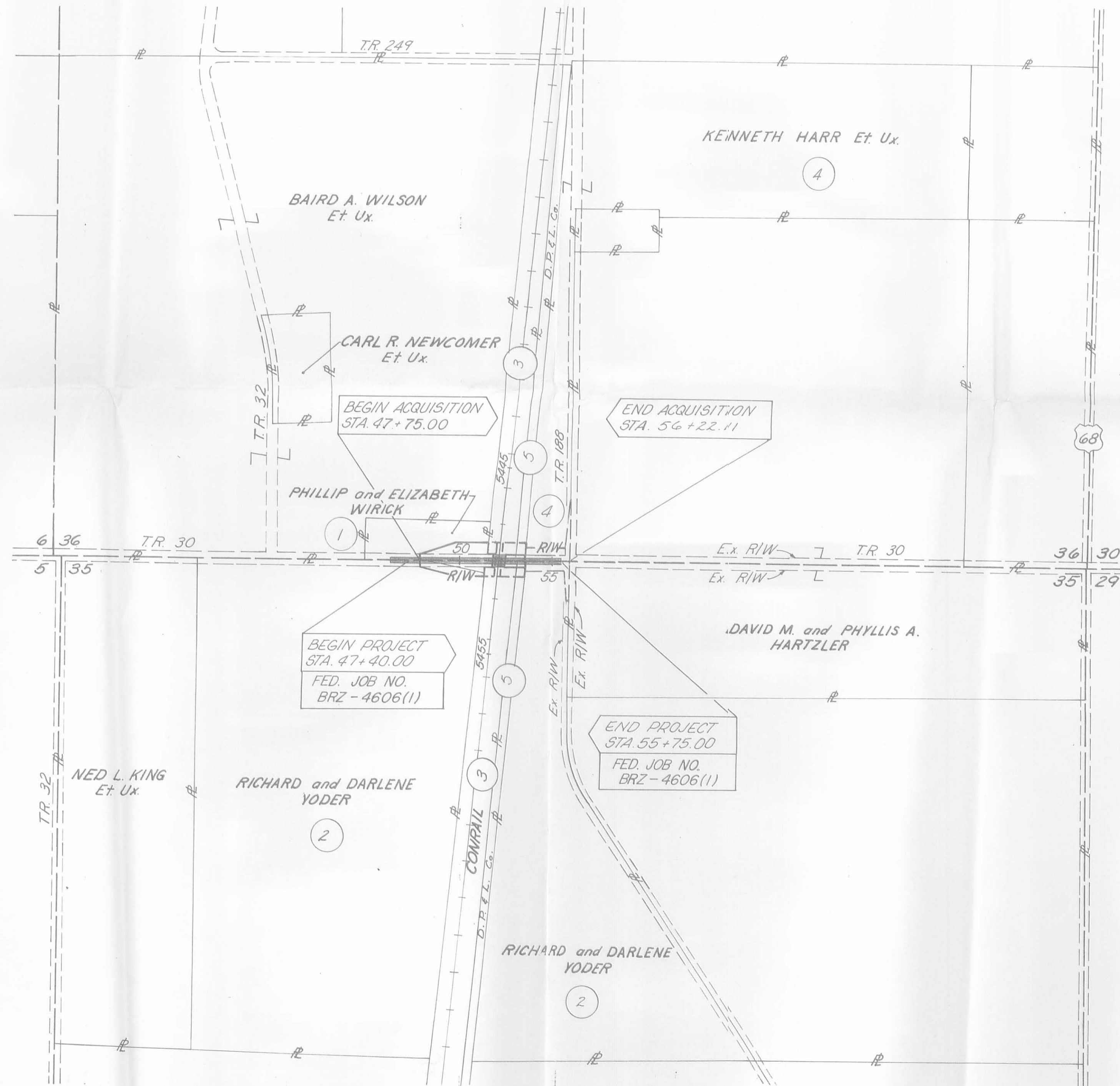
