The following described real estate situated in the State of Ohio, County of Logan, Township of Liberty, being part of Section 25, Town 4, Range 14, and part of Section 30, Town 5, Range 13, and more particularly described as follows:

Commencing at a railroad spike found in the center of T.R. 190 and in the east line of Section 30.

THENCE, with the center of T.R. 190, N.85°30'W. 199.43 feet to a railroad spike set, said spike being the True Point of Beginning of this description.

THENCE, continuing with the center of T.R. 190, N.85°30'W. 60.00 feet to a railroad spike set marking the southeast corner of Dale M. and Patricia A. McClure's 26.76 acre tract, D.B.367, Pg.801.

THENCE, with the east line of said McClure, N.4°44'52"E. 802.95 feet to a stone found in the north line of Section 30 marking the northeast corner of said McClure's 26.76 acre tract, and the southeast corner of said McClure's 172.96 acre tract, passing a 5/8 inch iron bar set at 20.00 feet.

THENCE, with the east line of said McClure's 172.96 acre tract, N.3°57'30"E. 1903.84 feet to a 5/8 inch iron bar set.

THENCE, S.85°56'49"E. 260.03 feet to a 5/8 inch iron bar set in the east line of Section 25.

THENCE, with the east line of Section 25, S.3°57'30"W. 1907.41 feet to a Re-survey monument found marking the southeast corner of Section 25.

THENCE, with the south line of Section 25, N.85°09'35"W. 200.07 feet to a 5/8 inch iron bar set.

THENCE, S.4°44'52"W. 802.59 feet to the point of beginning, passing a 5/8 inch iron bar set at 782.59 feet.

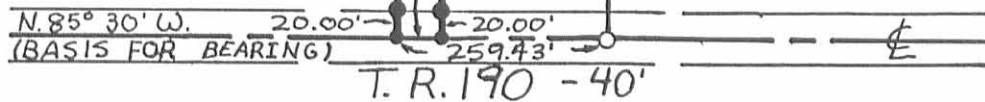
