

**BOUNDARY SURVEY OF THE HARROD CEMETERY  
McArthur Township, Logan County, Ohio.**

The following described real estate situated in the Township of McArthur, County of Logan, State of Ohio and being a part of Virginia Military Survey No. 10307 and being all of that tract of 1.831 Acres as deeded from Samuel Harrod, Sr. et ux to Trustees, Union Pleasant Hill Graveyard and Meeting House as described in Deed Volume No. Q Pages 6 and 7 (9-30-1846) and also being all of that tract of 1.575 Acres as deeded from J. Henry Anstine to Trustees of Harrod Graveyard as described in Deed Volume No. 50 Page 527 (4-6-1872) and now being more fully described as follows:

Beginning at a One Inch Round Iron Bar found at Station No. 55+29 of the centerline survey of T. R. No. 56 as recorded in Logan County Engineers Field Book No. 561 Page 49 and being the present northeast corner to Harrod Cemetery and the northwest corner to a 11.739 Acre tract in the name of Russell D. Williams et ux as recorded in Official Record No. 12 Page 491 (2-17-1985);

Thence with the west line of Williams' tract, S. 5°20'58" E. 377.23 feet to an original Two Inch Steel Corner Post found at the southeast corner to said Harrod Cemetery, passing through a 5/8" x 30" Rebar set at 25.10 feet;

Thence with the original south line of said Harrod Cemetery, S. 87°56'44" W. 407.02 feet to a 5/8" x 30" Rebar set at the southwest corner to said Harrod Cemetery, this line is also a north line of an original 54.946 Acre tract in the name of Bonnie C. Lane as recorded in Official Record No. 239 Page 892 (9-23-1994) and said corner being in the east line of a 2.774 Acre tract in the name of Lyle D. Faler, Jr. et ux as recorded in Official Record No. 253 Page 423 (4-6-1993);

Thence with the east line of Faler's tract and the west line of Harrod Cemetery, N. 4°33'21" E. 433.21 feet to a R. R. Spike found in the centerline of T. R. No. 56 and being the northeast corner to Faler's tract and the northwest corner to Harrod Cemetery, passing through a 5/8" x 30" Rebar set at 408.14 feet;

Thence with the centerline of T. R. No. 56, S. 81°18'00" E. 311.25 feet to a Large Bridge Nail found at an angle in said centerline, (Note: This centerline of T. R. No. 56 is the Basis of Bearing for this survey - S. 81°18'00" E.);

Thence continuing with the centerline of T. R. No. 56, N. 79°25'00" E. 30.00 feet to the place of beginning, containing 148,620.715 square feet or 3.412 Acres, more or less.

Of the above described tract, there is 8,578.125 square feet or 0.197 Acres in the right of way of T. R. No. 56.
