# LEGAL DESCRIPTION FOR LEE'S 2.047 ACRE TRACT

Being situate in the State of Ohio, County of Logan, Township of McArthur, and being a part of Virginia Military Survey 9904, and being more particularly described as follows:

Beginning for reference at a Mag nail set at the intersection of the centerlines of State Route 274 (variable right-of-way), Township Highway 221 (variable width right-of-way), and State Route 117 (variable width right-of-way);

thence with the centerline of State Route 117 S-6°31'00"-E, 150.00' (feet) to a Mag nail set at the **PRINCIPLE PLACE OF BEGINNING** for the tract hereinafter described;

thence with the South line of a 0.53 acre tract conveyed to A. Jean Fleenor, Trustee, by Deed recorded in Official Record 405, Page 539, with the South line of a 0.47 acre tract conveyed to Arturro Torres Suarez, etal., by Deed recorded in Official Record 730, Page 272, and with a South line of a 1.742 acre tract conveyed to David E. Martin by Deed recorded in Official Record 895, Page 596, N-83°29'00"-E, 395.48' (feet) to a 5/8" diameter iron bar found at 0.3' (feet) below grade, passing for reference an iron bar set on the right-of-way line of State Route 117 at 57.52' (feet);

thence with a West line of said Martin's 1.742 acre tract, S-6°47'49"-E, 225.15' (feet) to a 1" diameter iron pipe found at the Northeast corner of a 1.09 acre tract conveyed to Diane B. Pence, etvir., by Deed recorded in Official Record 753, Page 326, also being the Northwest corner of the remainder of an original 60 acre tract conveyed to Roland Marion Swonguer by Deed recorded in Deed Volume 352, Page 148, Tract 2, passing for reference a 1" diameter iron pipe found 0.3' (foot) below grade at 219.15' (feet);

thence with the North line of said Pence's tract S-83°29'00"-W, 396.58' (feet) to a Mag nail set on the centerline of aforementioned State Route 117, passing for reference an iron bar set on the right-of-way line of State Route 117 at 324.96' (feet);

thence with the centerline of State Route 117 N-6°31'00"-W, 225.15' (feet) to the place of beginning.

Containing 2.047 acres, 0.334 acre of which is within the road right-of-way, but being subject to the rights of all legal highways and all easements of record.






