Beginning at a railroad spike found on the east line of Virginia Military Survey 12168, the center-line of Township Road 95, the northeast corner of the Donald H. Nash 2.92 acre tract (O.R. 45, Pg. 515) and the southeast corner of the herein described tract. Said point being N 9°-09'-00" W, a distance of 2454.82 feet from a railroad spike found at the intersection of center-lines of Township Road 95 and County Highway 37.

THENCE, with the north line of the said 2.92 acre tract, S  $79^{\circ}-58'-27''$  W, a distance of 402.13 feet to a 3/4 inch square iron bar found.

THENCE, with the east line of the Farrell E. Knief 76.40 acre tract (O.R. 78, Pg. 797), N 9°-09'-00" W, a distance of 236.12 feet to a 5/8 inch iron rod set.

THENCE, N 79°-51'-10" E, a distance of 402.14 feet to a railroad spike set.

THENCE, with the east line of Virginia Military Survey 12168 and the center-line of Township Road 95, S 9°-09'-00" E, a distance of 236.87 feet to the point of beginning.

Containing 2.183 acres of which 0.136 acre is within the highway right-of-way.

The basis for bearings is based upon the east line of V.M.S. 12168 being S  $9^{\circ}-09'-00''$  E, and all other bearings are from angles and distances measured in a field survey by Lee Surveying and Mapping Company on November 13, 1992.





Beginning at an iron in the center of Logan County Highway 37 (also known as the Huntsville - Lewistown Pike) at the southeast corner of Virginia Military Survey 12168 and also in the center of Logan County Highway 95;




Thence South 79 Degrees 51 Minutes West 402.00 feet to an iron pin;

North 79 Degrees 51 Minutes East 402.00 feet to an iron pin in the center of said County Highway 95;

Thence with the centerline of said County Highway 95 South 9 Degrees 09 Minutes East 110.00 feet to the point of beginning.
