Commencing at a right-of-way monument found at Station 198+00, 30.00 feet right per Logan County Engineer's Plan L-27.

THENCE, with the east right-of-way of County Highway 130 (60 feet wide), N 07°-20'-00"W, a distance of 448.42 feet to a 5/8 inch iron rod set at the TRUE POINT OF BEGINNING.

THENCE, S 82°-14'-30"W, a distance of 30.00 feet to a MAG nail set.

THENCE, with the center-line of County Highway 130, N 07°-20'-00"W, a distance of 213.50 feet to MAG nail set.

THENCE, N 82°-47'-19"E, a distance of 109.77 feet to 5/8 inch iron rod set, passing a 5/8 inch iron rod set at 30.00 feet.

THENCE, S 07°-12'-41'E, a distance of 9.11 feet to a 5/8 inch iron rod set.

THENCE, S 59°-11'-42"E, a distance of 129.67 feet to a 5/8 inch iron rod set.

THENCE, S 07°-40'-02"E, a distance of 122.50 feet to a 5/8 inch iron rod set.

THENCE, S 82°-14'-30"W, a distance of 182.46 feet to the point of beginning.

Containing 0.919 acre of which 0.147 acre is within the highway right-of-way.

Property is subject to any and all previous easements and rights-of-way of record.






