THENCE, with the center-line of Township Road 37 and the north line of the Mark D. Brown 1.946 acre tract (O.R. 278, Pg. 295), S 82°-15'-00" W, a distance of 506.78 feet to a P.K. nail found.

THENCE, with the west line of the said 1.946 acre tract, S 7°-48'-41" E, a distance of 399.86 feet to a 5/8 inch iron rod found at the southwest corner of the said 1.946 acre tract and the TRUE POINT OF BEGINNING.

THENCE, S 7°-48'-41" E, a distance of 180.24 feet to a 5/8 inch iron rod set.

THENCE, S 82°-15'-00" W, a distance of 186.35 feet to a 5/8 inch iron rod set.


THENCE, N 7°-48'-28" W, a distance of 180.21 feet to a 5/8 inch iron rod found.
