GONTERMAN 4.000 ACRES

Lying in McPherson's Section, Town 7, Range 9, McArthur Township, Logan County, Ohio.

Being out of the Mary L. Gonterman original 63.765 acre tract as deeded and described in Official Record. 208, Page 670 of the Logan County Records of Deeds and being more particularly described as follows:

Beginning at a stone found in a monument box on the center-line of County Highway 91 at the intersection with the center-line of Township Road 31.

THENCE, with the center-line of County Highway 91, (60 feet wide), N 87°-13'-17" W, a distance of 1248.84 feet to a 3/4 inch bolt found.

THENCE, continuing with the center-line of County Highway 91, N 85°-48'-00" W, a distance of 433.32 feet to a railroad spike set at the TRUE POINT OF BEGINNING.

THENCE, S 4° -12'-00" W, a distance of 475.55 feet to a 5/8 inch iron rod set, passing a 5/8 inch iron rod set at 25.00 feet.

THENCE, N 83°-27'-44" W, a distance of 372.66 feet to a 5/8 inch iron rod set at the southeast corner of the Charles W. Oda 2.046 acre tract, (O.R. 205, Pg. 801).

THENCE, with the east line of the said 2.046 acre tract, N 4°-12'-00" E, a distance of 460.35 feet to a railroad spike found on the center-line of County Highway 91, passing a 5/8 inch iron rod found at 435.35 feet.

THENCE, with the center-line of County Highway 91, S 85°-48'-00" E, a distance of 372.35 feet to the point of beginning.

Containing 4.000 acres, of which 0.256 acre is within the highway right-of-way.

The basis for bearings is the center-line of County Highway 91 at the point of beginning, being N 85°-48'-00" W, and all other bearings are from angles and distances measured in a field survey by Lee Surveying and Mapping Co., Inc. on April 1, 1998.






