

Thence South 34°32'00" East 80.08 feet, continuing with the centerline of State Route 292 and following the east line of said 2.181 acre tract, to a point marking the *place of beginning*;

Thence *South 34°32'00 East 40.00 feet*, continuing with the centerline of State Route 292 and the east line of said 2.181 acre tract, passing at 19.92 feet a PK nail found at a northeast corner of said 51.4029 acre tract, thereafter following an east line of said 51.4029 acre tract, to a railroad spike found at the northeast corner of Robert L. 
