The following described real estate situated in the State of Ohio, County of Logan, Township of Pleasant, being part of the southeast $\frac{1}{4}$ of Section 11, Town 1, Range 8, M. R. S. and more particularly described as follows:

Beginning at a point in the south right-of-way line of State Route 47 that is S. $1^{\circ} 33' 19''$ W. 0.71 feet from a stone, said point being in the east line of Archie Foster's 30.0 acre tract as described in D. B. Vol. 391 Pg. 646 and being S. $75^{\circ} 25'$ W. 710.18 feet from a point in the east line of Section 11.

Thence with said R/W line N. $75^{\circ} 25'$ E. 296.19 feet to an iron bar at a north-east corner of Steven E. Pequignot's 4.38 acre tract as described in D. B. Vol. 400 Pg. 375.

Thence with said Pequignot's east line, being the west line of his 16 foot lane, S. $3^{\circ} 19' 42''$ W. 698.14 feet to an iron bar.

Thence N. $86^{\circ} 40' 18''$ W. 263.03 feet to an iron bar in the east line of said Archie Foster's 30.0 acre tract.

Thence with said Foster's east line N. $1^{\circ} 33' 19''$ E. 607.33 feet to the place of beginning.

Containing 4.09 acres more or less.

The bearing of the south line of S. R. 47 was assumed. All other bearings were established from angles turned in the field.

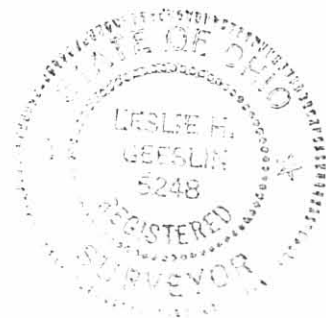
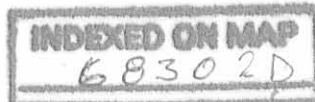
