

LEGAL DESCRIPTION FOR KELLY'S 0.010 ACRE TRACT

· Being situate in the State of Ohio, County of Logan, Township of Stokes, and being a part of Virginia Military Survey 12276, and being a part of Lot 229 of Wise Island View Allotment as recorded in Plat Cabinet "A", Slide 193, and a part of Lot 46-279 of Indian Lake Reservoir Lands as recorded in Plat "A", Slide 465, of the Logan County Plat Records, and being more particularly described as follows:

Beginning for reference at a 1" diameter iron pipe found on the Easterly line of Collingwood Avenue at the Northwesterly corner of Lot 230 as conveyed to Patrick N. Kelly, etux., by Deed recorded in Deed Volume 395, Page 850, Tract 1, of the Logan County Deed Records, also being at the Northeasterly corner of Lot 229, and that portion of said Lot 229 also conveyed to Patrick N. Kelly, etux., by Deed recorded in Deed Volume 395, Page 850, Tract 2, of the Logan County Deed Records;

thence with the Easterly line of said Collingwood Avenue (30' right-of-way) S-30°21'47"-W, 6.66' (feet) to an iron bar set at the PRINCIPLE PLACE OF BEGINNING for the tract hereinafter described, said iron bar set also being at the Northeasterly corner of that portion of Lot 229 conveyed to Joseph J. Moran by Deed recorded in Official Record 258, Page 864, Parcel 2, of the Logan County Records;

thence with an existing chain link fence line, S-36°35'33"-E, 126.00' (feet) to an iron bar set on the Easterly line of aforementioned Lot 46-279, also being on the Westerly line of Lot 46-280 of Indian Lake Reservoir Lands as conveyed to Patrick N. Kelly, etux., by Deed recorded in Deed Volume 395, Page 850, Tract 3, passing for reference the Easterly line of aforementioned Lot 229 at 104.91' (feet);

thence with the line between said Lots 46-279 and 46-280, S-33°51'47"-E, 11.20' (feet) to an iron bar set, passing for reference a corner of said Lot 46-280 at 7.80' (feet);

thence with the Southeasterly line of said Lot 46-279, S-49°55'13"-W, 6.04' (feet) to an iron bar set at the Northeasterly corner of that portion of said Lot 46-279 conveyed to aforementioned Joseph J. Moran by Deed recorded in Official Record 258, Page 864, Parcel 5, of the Logan County Records;

thence with the Northerly line of said Moran's portion of said Lot 46-279 and with the Northerly line of aforementioned Moran's portion of Lot 229, N-33°51'47"-W, 137.71' (feet) to the place of beginning, passing for reference the Easterly line of said Lot 229 at 30.75' (feet).

Containing 0.010 acre, 0.006 acre of which is a part of Lot 229 of Wise Island View Allotment and 0.004 acre of which is a part of Lot 46-279 of the Indian Lake Reservoir Lands, but being subject to the rights of all legal highways and all easements of record.

Being 0.004 acre out of that portion of Lot 46-279 conveyed to Patrick N. Kelly, etux., by Deed recorded in Deed Volume 395, Page 850, Tract 4, and 0.006 acre out of that portion of Lot 229 also conveyed to Patrick N. Kelly, etux., by Deed recorded in Deed Volume 395, Page 850, Tract 2, of the Logan County Deed Records.

The herein described tract is to be attached to an adjoining parcel and is not to be used as a separate and independent tract.

The foregoing description prepared by and in accordance with a Survey by William D. Edwards, Professional Surveyor No. 7574, November 10, 2008. All iron bars set are 5/8"x30" iron re-bar with a yellow plastic cap stamped "EDWARDS PS 4792 PS 7574". The basis of bearings for the herein described tract is the Easterly line of Collingwood Avenue per an assumed bearing of S-30°21'47"-W.

DESCRIPTION FOR PART LOT 229 of WISE ALLOTMENT OF ISLAND VIEW

Beginning at a point in Collingwood Ave.

S. 26°-20' W. 6.52 feet from the northwest corner of Lot 230.

Thence continuing S. 26°-20' W. 35.48 feet to an angle in said street; thence S. 54°-15' W. 18.0 feet; thence S. 39°-18' E. to the shore line of Indian Lake passing irons at 50.75 feet, 86.00 feet and 118.00 feet; thence with the shore line in a northeasterly direction to a point which is 6.00 feet west of and parallel with the west line of Lot 230. Thence N. 40°-40' W. parallel to and 6.00 feet from the west line of Lot 250 to the place of beginning.
