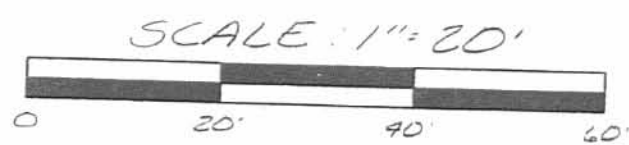


LEGEND:

SURVEY FOR JOHN KELLEY  
0.073 ACRES  
DECEMBER 22, 1994

The following described tract of land is situated in the State of Ohio, County of Logan, Township of Stokes, Section 23, Town 6, Range 8, being all of Lot #8 of the Indian Lake West Side Addition Number Three, recorded in Plat Book C, page 65, said Lot #8 being in the name of Betty L. Andrews and Joyce D. Adkins' and recorded in deed volume 377, page 41, said Lot #8 being more particularly described as follows:

Beginning at an iron pin set at the southeast corner of said Lot #8 and at the northeast corner of Lot #7 of said addition, said Lot #7 being in the name of Betty L. Andrews and Joyce D. Adkins, recorded in deed volume 377, page 41;

thence North 86°20'00" West (bearing based on an assumed meridian with all others based on angles turned) 80.04 feet, following the south line of said Lot #8 and the north line of said Lot #7, to the northeast corner of Lot #2 of said addition, the southeast corner of Lot #3 of said addition, said Lot #2 in the name of Michael J. and Brenda Hitchcock, recorded in official record 116, page 503, said Lot #3 in the name of Don E. and Emma K. Young, recorded in deed volume 372, page 39, said corner being South 10°39'09" West 0.25 feet from a 5/8" iron pin found with cap marked "L GEESLIN S 5248;"

thence North 01°05'57" East 39.88 feet, following the west line of said Lot #8 and the east line of said Lot #3, to an iron pin set at the southeast corner of Lot #4 and at the southwest corner of Lot #9 of said addition, said Lot #4 in the name of Robert A. and Judith A. Long, recorded in official record 139, page 877, said Lot #9 in the name of Dale T. and Sandra K. Brodnick, recorded in deed volume 377, page 857;

thence South 86°17'51" East 80.05 feet, following the north line of said Lot #8 and the south line of said Lot #9, to an iron pin set in the west line of Viola Lane;

thence South 01°05'57" West 39.83 feet, following the west line of Viola Lane and the east line of said Lot #8, to the place of beginning, containing 0.073 acre, more or less, and subject to all valid easements and restrictions of record.

The above description was prepared from an actual field survey made under the supervision of Paul R. Clapsaddle, Registered Surveyor #6140 during the month of December, 1994. Iron pins set are 5/8" by 30" reinforcing rods with caps marked "CLAPSADDLE, R.S. #6140." Bearings indicated herein are based on an assumed meridian and are to denote angles only.

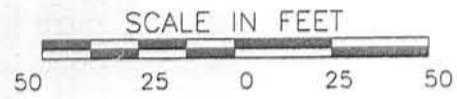
