Thence with the north line of said drive N. 48° 07' 00" W. 50.70 feet to a 5/8 inch iron bar set at the southeast corner of Richard Wagonrod's 0.10 acre tract as described in O. R. Vol. 185 Page 400.

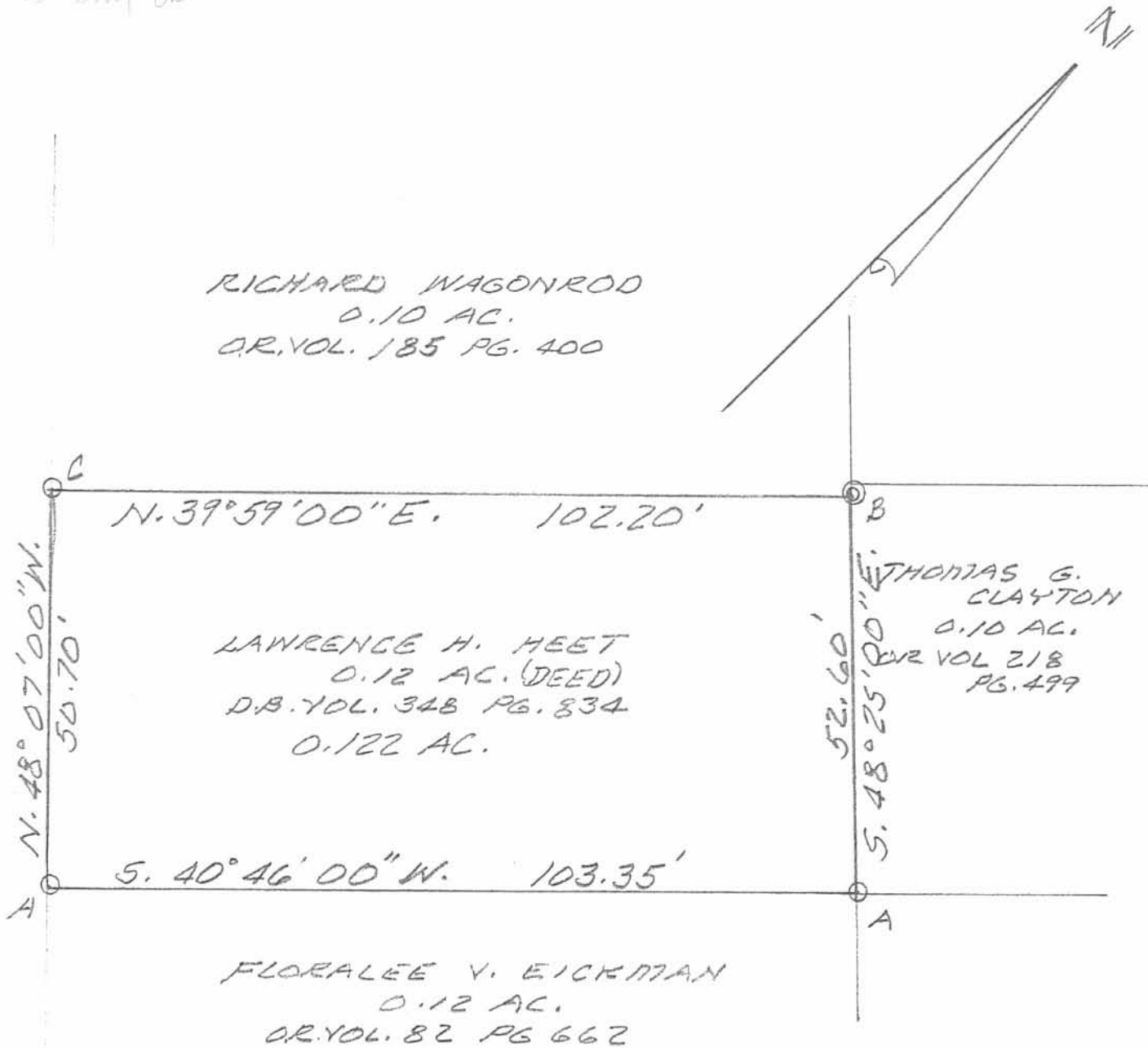

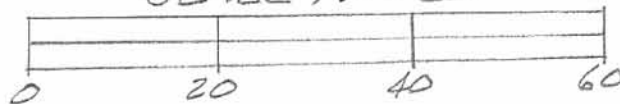
