THENCE, with the center-line of County Highway 88, S 88°-10'-06"E, a distance of 234.65 feet to the point of beginning.

Containing 1.353 acres, of which 0.090 acre is within the highway right-of-way.

The basis for bearings is the center-line of County Highway 88, being N 88°-10'-06"W, and all other bearings are from angles and distances measured in a field survey by Lee Surveying and Mapping Co., Inc. on October 1, 2003.



The following described 79.478 acre tract is situated in the State of Ohio, County of Logan, Township of Stokes, Section 20, Township 6, Range 8 East, being all of the remainder of John P. Thence **South 01°48'26" West** (assumed bearing) **2655.51 feet**, departing from the centerline of County Road 88, following the west line of said 40.5 acre Parcel I, Tract II and said Section 21, the east line of the remainder of said original 80 acre Parcel I and Section 20, passing iron pins set at 16.75 feet and at 2653.46 feet, to a point at the southeast corner of the northeast quarter of said Section 20, at the northwest corner of Modestus J. and Joanne M. Maag's 160 acre Tract I described in Deed Record 312, page 333, and at the northeast corner of David M. and Dinah L. Dague's 50 acre Tract I described in Official Record 797, page 747;

Thence **North 88°30'42" West 1324.59 feet**, following the east-west half Section line of said Section 20, the south line of the remainder of said original 80 acre Parcel I, and the north line of said 50 acre Tract I, passing at 831.72 feet an iron pin set at the northwest corner of said 50 acre Tract I and at the northeast corner of John P. Reinhart and Mary E. Reinhart Goings' 30 acre Parcel II, Tract Two described in Official Record 631, page 59, thereafter following a north line of said 30 acre Parcel II, Tract Two, to an iron pin set at the southwest corner of the remainder of said original 80 acre Parcel I, at the southeast corner of James and Beatrice Schaub's second 40 acre tract described in Official Record 13, page 789, and at the northeast corner of John P. Reinhart and Mary E. Thence North 01°46'53" East 2658.48 feet, following said north-south quarter Section line, the west line of the remainder of said original 80 acre Parcel I, the east line of said Schaub's second described 40 acre tract, and the east line of C. Bernard and Ida Rose Andrews' 40 acre Parcel I described in Official Record 457, page 674, passing at 2641.73 feet an iron pin set, to a magnetic nail set in the centerline of County Road 88 and in the north line of said Section 20;

Thence **South 88°22'58"** East 779.90 feet, following the centerline of County Road 88, the north line of said Section 20, and a north line of the remainder of said original 80 acre Parcel I, to a railroad spike found at the northwest corner of Bernard A. Wischmeyer's 1.353 acre tract described in Official Record 700, page 184 (said 1.353 acre tract formerly part of said original 80 acre Parcel I);



Thence departing from the centerline of County Road 88, entering said Section 20 and following five (5) consecutive lines between said 1.353 acre tract and the remainder of said original 80 acre Parcel I;

- (1) South 01°56'53" West 169.39 feet, passing at 20.05 feet a 5/8 inch iron pin found with cap marked "LEE PS 6359", to a 5/8 iron pin found with cap marked "LEE PS 6359";
- (2) South 88°45'18" East 48.95 feet, to a 5/8" iron pin found with cap marked "LEE PS 6359";
- (3) South 01°21'26" West 95.35 feet, to a 5/8" iron pin found with cap marked "LEE PS 6359";
- (4) **South 87°43'33" East 195.07 feet**, to a 5/8" iron pin found with cap marked "LEE PS 6359";
- (5) North 00°16'32" West 266.81 feet, passing at 246.91 feet a 5/8 inch iron pin found with cap marked "LEE PS 6359", to a railroad spike found in the centerline of County Road 88 at the northeast corner of said 1.353 acre tract, at a northwest corner of the remainder of said original 80 acre Parcel I, and in the north line of said Section 20;

Thence South 88°22'58" East 311.23 feet, following the centerline of County Road 88, a north line of the remainder of said original 80 acre Parcel I, and the north line of said Section 20, to the place of beginning, containing 79.478 acres, more or less, and being subject to all valid easements and restrictions of record. Of the above described 79.478 acre tract, 0.419 acre is in the right of way of County Road 88.
