## ALICE WREN    1 ACRE LOT

Situated in Fractional Section 30, T-7, R-9, M. R. S. in Washington Township, Logan County, Ohio, and being out of that Alice I. Wren lands as described in Volume 192, Page 445 of the Logan County Deeds Records and better described as follows:

Beginning at a railroad spike set at the Southwest corner of the Alice I. Wren 69.98 acre tract as described in said Volume 192, Page 445. This point lying in the center-line of Township Road No. 213 and also lying on the Greenville Treaty Line.

THENCE, with the West line of the said 69.98 acre tract, N 2°-26' W, a distance of 210.0 feet to an iron rod set for the Northwest corner of this survey, passing an iron rod set at 20.14 feet.

THENCE, N 80°-00' E, a distance of 210.0 feet to an iron rod set for the Northeast corner.

THENCE, S 2°-26' E, a distance of 210.0 feet to a railroad spike set in the center of Township Road 213, also being on the Greenfield Treaty Line, passing an iron rod at 189.96 feet.

THENCE, with the center-line of the road and with the Greenville Treaty Line, S 80°-00' W, a distance of 210.0 feet to the point of beginning. Containing 1.00 acres.

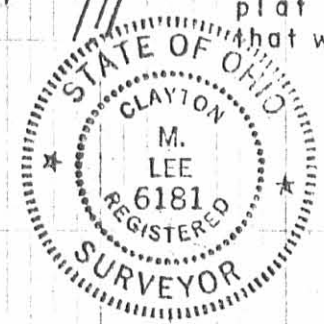

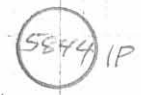
