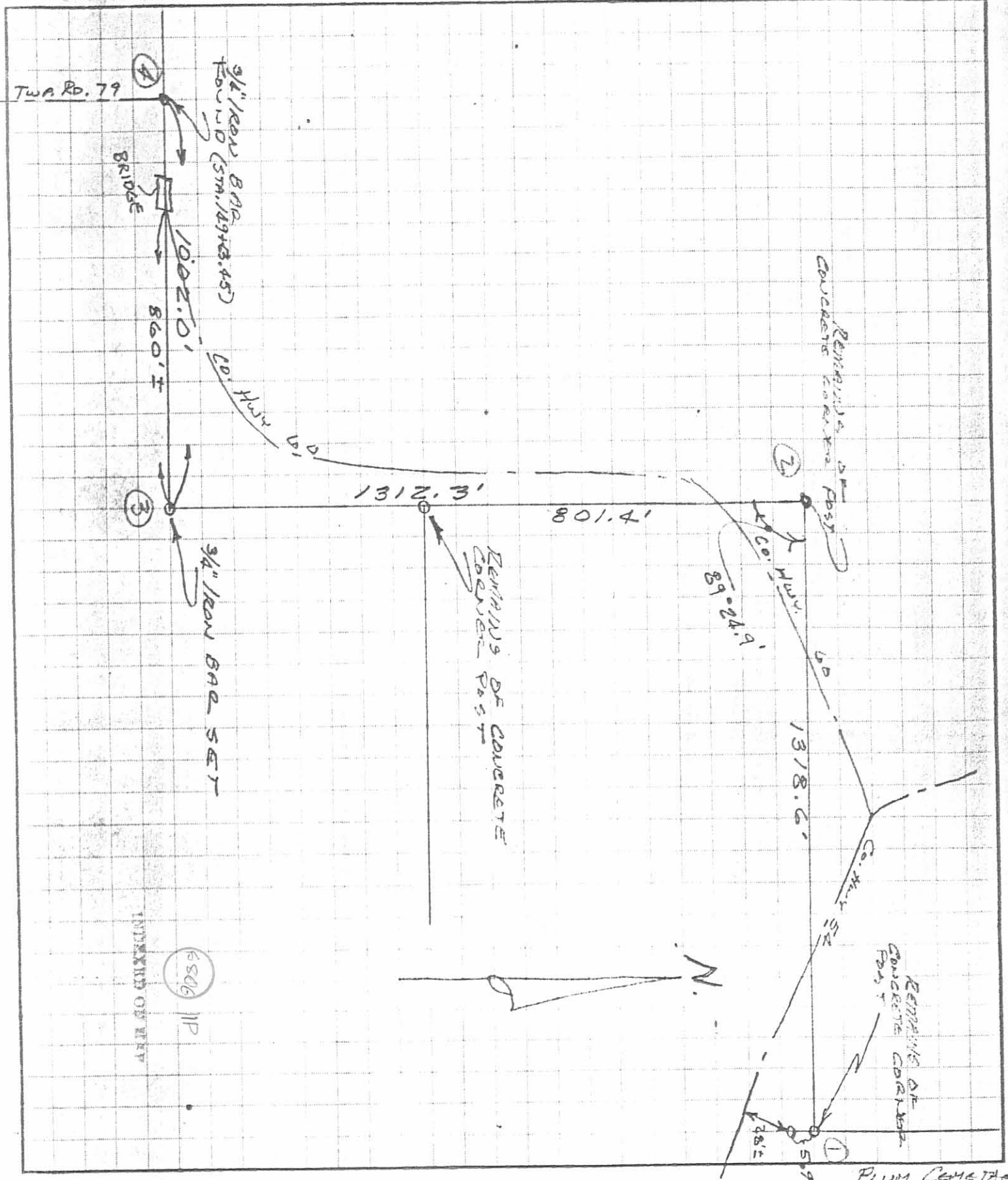


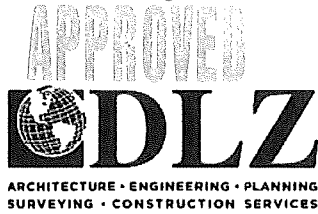

HEPPARD, CO-TRUSTEES 6.506 ACRES

Situate in the State of Ohio, Logan County, Bloomfield Township and Washington Township and lying in Section 22, Town 7, Range 8, South and East of the First Principle Meridian, and being out of the 272.454 acres as conveyed to Monte Heppard, Co-Trustee and Dawn Heppard, Co-Trustee by deed of record in Official Record 1124, Page 720, Tract I (all records referenced herein refer to the Logan County Records of Deeds) and being more particularly described as follows:

COMMENCE at a magnetic nail set at P.I. Station 146+55.8 (Logan County Engineer's Field Book 692, Page 23) on the center-line of County Road 60 (50 feet wide).

THENCE, with the center-line of the existing pavement of said County Road 60, the following courses:

With a curve to the left, having a delta angle of 8°-08'-50", a radius of 438.43 feet, an arc distance of 62.34, a chord bearing North 86°-32'-40" East, a distance of 62.29' feet to a point;

North 82°-28'-15" East, a distance of 37.40 feet to a magnetic nail set at a point of curvature;

With a curve to the left, having a delta angle of 66°-27'-27", a radius of 381.34 feet, an arc length of 442.32 feet, a chord bearing North 49°-14'-31" East, a distance of 417.94 feet to a magnetic nail set;

North 16°-00'-48" East, a distance of 37.40 feet to a point at a point of curvature;

With a curve to the left, having a delta angle of 17°-28'-17", a radius of 438.43 feet, an arc length of 133.69 feet, a chord bearing North 07°-16'-39" East, a distance of 133.17 feet to a point;

North 01°-27'-29" West, a distance of 176.55 feet to a magnetic nail set at a point of curvature, passing a magnetic nail set at a distance of 18.71 feet and referenced by a right-of-way monument found bearing North 50°-21' 51" East, a distance of 35.52 feet;



With a curve to the right, having a delta angle of 30°-33'-19", a radius of 363.92 feet, an arc length of 194.08 feet, a chord bearing North 13°-49'-10" East, a distance of 191.78 feet to a magnetic nail set:

North 29°-05'-50" East, a distance of 151.55 feet to a magnetic nail set on a point of curvature;

With a curve to the left, having a delta angle of 3°-30'-41", a radius of 3096.07 feet, an arc length of 189.74 feet, a chord bearing North 26°-35'-43" East, a distance of 189.71 feet to a magnetic nail set:

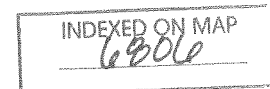
North 26°-24'-33" East, a distance of 124.45 feet to a magnetic nail set: and

With a curve to the right, having a delta angle of 5°-48'-55", a radius of 194.39 feet, an arc length of 19.73 feet, a chord bearing North 29°-19'-00" East, a distance of 19.72 feet to a magnetic nail set, referenced by a 1/2 inch iron rebar found bearing North 08°-58'-05" East, a distance of 61.11 feet, said magnetic nail being on the line common to said 272.454 acre tract and that 30.60 acres as conveyed to Chad J. Homan by deed of record in Official Record 1156, Page 931;

THENCE, South 01°-18'-03" West, a distance of 1250.66 feet, with said common line and the west line of that 122.90 acre tract as conveyed to D. Bruce Tracey and Carol Tracey by deed of record in Official Record 220, Page 753, passing a 5/8 inch iron rebar set (I.D. cap stamped "DLZ OHIO INC.") at a distance of 56.56 feet, to a 5/8 inch iron rebar set (I.D. cap stamped "DLZ OHIO INC.") on a quarter section line of Section 22, being on the southeast corner said 272.454 acre, the westerly line of said 122.90 acre tract and a northeast corner of that 70.50 acre tract conveyed to FRT KNIEF LLC, by deed of record in Official Record 697, Page 30, Parcel IV, Tract I;

THENCE, North 89°-22'-55" West, a distance of 679.62 feet, with said common line to the 272.454 acre and 70.50 acre tracts and also being a quarter section line of said Section, passing a 5/8 inch iron rebar set (I.D. cap stamped "DLZ OHIO INC.") at a distance of 518.49 feet, to the POINT OF BEGINNING.

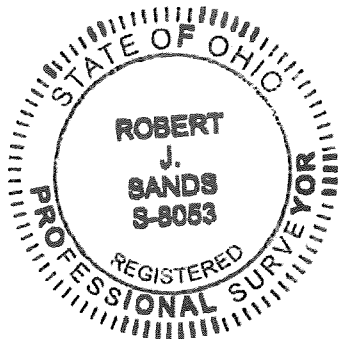
Containing 6.506 acres, more or less, of which approximately 0.831 acre is within the highway right-of-way. There is approximately 4.573 acres within Bloomfield Township and approximately 1.933 acres within Washington Township.



The bearings in the above description are based on the grid bearing of N 89°-22'-55" W, for the quarter section line of Section 22 as determined by a GPS network of field observations performed in March, 2023 and are based upon the Ohio State Plane Coordinate System, North Zone, NAD83 (2011).

All rebar set are 5/8 inch in diameter and 30 inches in length, with a yellow cap stamped "DLZ OHIO INC."
