

ROBINSON SURVEY
House Lot

The following described real estate situated in the Village of West Liberty, Township of Liberty, County of Logan, State of Ohio and being parts of Lots No. 1,2,7 and 8 of Runkle and Young's Sub-division of Section No. 33, Town 5, Range 13, B.M.R.S. as recorded in Deed Volume T Pages 68-69 (4-20-1849) and being part of the First and Second Tracts of Deed Volume 370 Pages 811-812 (6-8-1977) and being out of Permanent Parcel No. 20-144-15-02-006, 3.11 Acres in the name of Forrest N. Robinson and being more particularly described as follows:

Beginning at a 5/8" x 30" Rebar found at the northeast corner to said 3.11 Acre tract and being a southeast corner to Thomas R. Woodruff's present 0.613 Acre tract as described in Official Record No. 73 Page 769 and being in the east line of Section No. 33, T.5, R.13, B.M.R.S., which is also the west line of Taylor Street (60 feet wide);

Thence with the east line of Section No. 33 and the west line of Taylor (Note: This line is the Basis of Bearing for this survey), S. 4° 44' W. 90.00 feet to a 3/4" Iron Pipe found at the northeast corner to Valerie Sue Robinson Hunt's present 0.33 Acre tract as described in Deed Volume No. 402 Page 772 (12-12-1983);

Thence with the north line of said Hunt's tract and extension thereof, N. 85°12' W. 250.00 feet to a 5/8" x 30" Rebar set, passing through a 3/4" Iron Pipe found at Hunt's northwest corner;

Thence N. 4° 44' E. 98.87 feet to a 5/8" x 30" Rebar set in the south line of Woodruff's tract;

Thence with the south line of Woodruff's tract, S. 83°10' E. 250.16 feet to the place of beginning, containing 23,607.86 feet or 0.542 Acres, more or less.

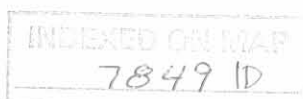
