

SURVEY FOR VERNON CURRENT
DECEMBER 18, 1989

The following described tract is situated in the State of Ohio, County of Logan, Townships of Monroe and Zane and is part of Virginia Military Survey No. 3159 and part of Virginia Military Survey No. 4676. Said described tract is also part of Florence B. Shirk's 339.780 acre tract as described in Deed Book Volume 400, Page 311 and is more fully described as follows:

Commencing at a 5/8 inch diameter iron bar found at Station 44+70 of County Highway No. 146 as shown in Field Book No. 573, Page 32;

Thence North-54°-18'-06"-East (this is the basis of bearing and is assumed) 1016.84 feet with the centerline of County Highway No. 146 to a P.K. nail set, said nail being the point of beginning of this description;

Thence North-24°-28'-48"-West 602.85 feet to a 5/8 inch diameter iron bar set, passing a 5/8 inch diameter iron bar set at 25.48 feet;

Thence North-53°-38'-03"-East 351.24 feet to a 5/8 inch diameter iron bar set in the south line of Lowell Akey's tract as described in Deed Book Volume 288, Page 111;

Thence South-42°-18'-23"-East 293.77 feet with the south line of Akey's tract to a railroad spike found in the centerline of County Highway No. 146, passing a 5/8 inch diameter iron bar set at 263.57 feet;

Thence South-8°-28'-28"-West 423.30 feet with the centerline of County Highway No. 146 to a 5/8 inch diameter iron bar found at Station 56+95;

Thence South-54°-18'-06"-West 207.34 feet with the centerline of County Highway No. 146 to the point of beginning.
