S 30°-17'-37" W, a distance of 26.00 feet to a 1/2 inch iron pipe found.

S 22°-18'-39" W, a distance of 225.71 feet to a 1/2 inch iron pipe found.

S 47°-55'-00" W, a distance of 161.00 feet to the point of beginning.

Containing 2.045 acres of which 0.274 acre is within the highway right-of-way.

The basis for bearings is based upon the center-line of Township Road 157 at the most southerly corner of this 2.045 acre tract being S 47°-55'-00" W, and all other bearings are from angles and distances measured in a field survey by Lee Surveying and Mapping Company on August 7, 1995.
