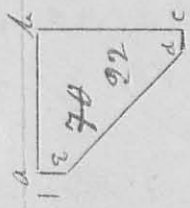

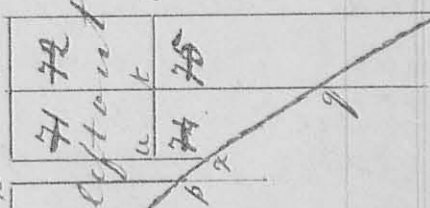

Miller, as represented by the above plat, Reynolds Street bears $\text{N } 2^{\circ} 30' \text{ W}$, & other Streets and alleys parallel & at right angles with said street, Lots 12, 13 & 14 are part of first addition made 27th May 1841. Lots from 15 to 69 inclusive, except 27, 28, 29 & 30 are each 50 feet in front and extend back 150 feet, Lots 71 & 72 are each 75 feet in front and 150 feet back.
